### 3879 RECORD OF THE MEETING

The record of the meeting held on 19 October 2001 was agreed and signed by the chairman as correct with one amendment to minute 3775 it being: .

Resolved that the permitted hours in respect of the Public Entertainment Licence for Music, Singing and Dancing on Sundays should be from 12 noon until 12 midnight and from 12 noon until 2.00am in the morning on Sundays immediately preceding a bank holiday Monday.

### ITEMS TO BE DEALT WITH UNDER DELEGATED POWERS

# 3880 APPLICATION FOR VARIATION OF HOURS ON AN EXISTING PUBLIC ENTERTAINMENT LICENCE BAR RIO NIGHT-CLUB, FEATHERBY ROAD, GILLINGHAM

The committee considered a report asking them to determine an application for variation of the existing public entertainment licence at Bar Rio Night-club, Featherby Road, Gillingham in order to permit music, singing and dancing on Sundays from 10.00am until 1.00am the following morning.

There were a number of letters of complaint received from local residents and six residents spoke at the meeting giving reasons why they felt the hours of the public entertainment licence should not be extended.

The environmental protection team commented regarding compliance with condition 17 regarding notice and Police had no objection in principle to the granting of a public entertainment licence on Sundays but expressed concerns over the hours applied for on that day.

### Licensing and Safety Committee, 30 November 2001

Considerable discussion took place regarding this matter.

Resolved that the permitted hours in respect of the public entertainment licence for music, singing and dancing on Sundays should be from 10 am until 1.00am the next morning on Sundays immediately preceding a bank holiday Monday and from 10.00am to 11.30pm on all other Sundays.

### 3881 CONTROL OF LATE NIGHT PREMISES

The committee were informed of the legal position regarding the control of hours of opening of certain classes of premises.

The report set out several options available to the committee.

### Resolved that:

- (i) the report and options be noted;
- (ii) officers consider each premises where complaints are received on their individual merits taking account of the most suitable option available for action.
