3935 APOLOGIES FOR ABSENCE

Apologies were received from Councillor Madhu Ruparel.

3936 RECORD OF THE MEETING

The record of the meeting held on 30 November 2001 was agreed and signed by the chairman as correct.

ITEMS TO BE DEALT WITH UNDER DELEGATED POWERS

3937 APPLICATION FOR PROVISIONAL PUBLIC ENTERTAINMENT LICENCE, THE SOURCE CAFÉ BAR (TO BE KNOWN AS CENTRAL BAR AND CLUB) 9-11 CLOVER STREET, CHATHAM

A report was presented to the committee for consideration which sought the determination of an application for the grant of a provisional public entertainment licence in respect of the Source Café Bar, 9-11 Clover Street, Chatham. Three letters of objections were received and Mr James Jeffryes representing the Gibraltar Terrace Residents Association spoke on behalf of the association.

Resolved that:

(a) a provisional public entertainment licence for six months should be granted subject to all the requirements detailed in paragraph 4.5 of the Licensing Co-ordinator's report being complied with prior to the commencement of public entertainment at the premises and the council then confirming the licence;

- (b) the permitted hours of the licence shall be from 12.00 noon until 1.00am the following morning, Monday to Saturday and until 12 midnight on Sundays (including Easter Day) and until 1.00am the next morning on Sundays immediately preceding a bank holiday Monday;
- (c) there shall be no admission to the premises after 11pm;
- (d) the licencee shall hold bi-monthly meetings with local residents to discuss any problems that may arise.

3938 DOOR SUPERVISOR REGISTRATION – REPRESENTATION AGAINST REFUSAL

The committee considered an exempt report which sought to determine an appeal against the decision of the licensing co-ordinator to refuse to grant a door supervisors registration.

The appellant and the licensing co-ordinator put their respective cases and were questioned by the committee.

Resolved that Mr B be not granted a door supervisor registration, but be invited to reapply after one year.

3939 EXCLUSION OF THE PRESS AND PUBLIC

Resolved that under section 100A(4) of the Local Government Act 1972 the press and public be excluded from the meeting for the consideration of minute 3938 (appeal against refusal of door supervisor registration) on the grounds that it involved the likely disclosure of exempt information as defined in paragraph 7 part 1 of the schedule 12A of the Act.
