OUTCOMES OF HOUSING BENEFIT COUNTER FRAUD INVESTIGATIONS

1 Summary

1.1 To inform Members of progress in investigating allegations of housing and council tax benefit fraud during the period February to March 2007.

2 Decision issues

2.1 Following the Council's decision to establish this committee, it is within the remit of this committee to take decisions regarding accounts and audit issues.

3 Background

- 3.1 Medway Council has had a sanction policy since 2002 following changes to the way benefit investigations should be conducted. These changes resulted in a more rigorous investigative standard being adopted which lead to specific outcomes, known as sanctions. Namely, that local authorities should consider the use of one of the following courses of action following a successful investigation:-
 - Prosecution
 - Issue of a caution
 - Issue of an administrative penalty (fine).

4 Outcome of Benefit Investigations

- 4.1 In the 2006/07 financial year, the investigations team has identified £406,487 of fraudulent overpayments of Housing and Council Tax Benefit. This has led to 24 successful prosecutions, and the issue of 49 cautions and 2 administrative penalties.
- 4.2 Since the last report, investigations have resulted in the issue of twelve sanctions (Annex A).
