Constitutional changes – 8 January 2008

To report on a number of proposed changes to the constitution, prior to consideration and approval at Council on 17 January 2008.

Award of contract for sensory impairment service – 8 January 2008

This report will recommend the award of contract for the assessment and provision of aids for visual impairments.

Waste services collection and street cleaning – 29 January 2008

Cabinet will be asked in this report to approve the options appraisal for proceeding with the procurement process for this contract.

Learning Platforms Contract Award – 29 January 2008

Cabinet considered a report (Gateway 1) setting out the business case for the procurement of a learning platform on behalf of Medway schools on 25 September. Cabinet approved the use of the Becta Learning Services Framework for this procurement. This report will go to Cabinet as Gateway 3 (contract award).

Treasury Management and Annual Investment Strategy - 19 February 2008

The report will set out the likely scenario for the Council's borrowing and investments for 2008/2009 along with recommending the statutory borrowing limits and prudential guideline limits for 2008/2009 to be agreed by Council on 28 February 2008.

Procuring of support services at Regent House, Chatham – 11 March 2008

This Gateway 1 report will consider options for procuring support services at Regent House
