FINALISING THE NEGOTIATION OF MEDWAY'S SECOND LOCAL AREA AGREEMENT 2008-11

Summary

This report requests the Business Support Overview and Scrutiny Committee to consider and comment on the performance targets to be included in Medway's local area agreement for recommendation to full Council. For targets where the process of negotiation with the government office is still ongoing, Cabinet will be asked to delegate authority to conclude that to the Chief Executive in consultation with the Leader.

1. Budget and Policy Framework

- 1.1 The priorities for the local area agreement (LAA) flow from and are consistent with Medway's community plan, adopted as part of the policy framework in November 2006.
- 1.2 Government guidance makes agreement of the LAA a local choice function giving the council the flexibility to assign responsibility for its agreement to either the Cabinet or to council. At the council meeting of 17 April 2008 the responsibility was reserved to Council. A special meeting to agree the LAA will be held on 28 May 2008.

2. Background

2.1 The council in partnership with the Local Strategic Partnership is required to negotiate a new local area agreement with government by 30 May 2008. The LAA is the key document setting the improvement priorities for Medway to be delivered by the Council and its partners. It must include the list of priorities, and a selection of up to 35

performance indicators to measure achievement of the priorities. The 35 must be drawn from a list of 198 national indicators set by government. Against each of the 35 indicators we must set annual performance targets for the 3 years of the LAA. In addition to the 35 there are 16 statutory targets relating to early years and educational achievement. These are subject to separate target setting procedures but where data is available this is included in appendix 3 to this report.

- 2.2 The government has imposed a very tight timescale for agreeing the LAA, with a series of milestones leading to the submission deadline of 30 May. Despite only receiving formal sign off from the Secretary of State in June, the LAA will be 'backdated' with an official start date of 1 April 2008. It will run for the three financial years to 31 March 2011. It will be subject to annual review.
- 2.3 The list of LAA priorities at appendix 1 flows from the community plan agreed by the Council in November 2006. It is important to note that the LAA priorities are for the Council and its partners, not just for the Council alone. The priorities as they affect the Council are consistent with its own priorities in the performance plan.
- 2.4 The LSP Board considered and supported the list of priorities for the LAA at its meeting in January 2008. Business Support Overview and Scrutiny Committee received an update report on 7 February 2008. Cabinet endorsed the priorities at its meeting on 11 March 2008.
- 2.5 Once the priorities were agreed, officers within the Council and partner agencies worked to develop a list of potential indicators to measure achievement of LAA priorities. Up to 35 indicators had to be chosen from the list of 198 national indicators. This was quite a complex exercise as the list of indicators is new and many have not been gathered before. Officers were mindful that to be meaningful the LAA must include measures where it is important that the council make improvement. However, the targets must be realistic within the resources available to the Council and its partners, and must focus on areas where the council is in a position to directly influence the outcome.
- 2.6 The list of 35 indicators was submitted to the Government Office for the South East (GOSE) on 31 March 2008, following consideration by Cabinet on 11 March and the LSP Board on 18 March. A briefing for all members was held on 3 April. The list of indicators can be found at appendix 1.
- 2.7 The local public service agreement (LPSA) has one year to run and comes to an end on 31 March 2009. These targets are shown at appendix 2. The current LPSA targets will sit alongside the LAA for the remaining year of the LPSA agreement –in addition to the 35 LAA targets.

3. Target Setting

3.1 <u>Summary of overall progress</u>

- 3.1.2 Officers within the council and across partner organisations have been negotiating potential performance targets with GOSE. This has been a time-consuming process with GOSE advisers needing to satisfy themselves and central government departments. In some instances this has meant that where the council had hoped to have secured informal agreement, it is now being asked to revisit target levels.
- 3.1.2 Appendix 3 shows annual targets for each of the indicators. Where these are shown in bold informal agreement has been reached between Medway and GOSE. Where the figures are not in bold they represent Medway's current negotiating position. In some instances officers are waiting for GOSE feedback on the targets, in others officers are finalising figures with partner organisations before submission to GOSE. In a small number of cases data is still not yet available.
- 3.1.3 Although all of the LAA indicators come from the new national indicator set, guidance is not yet available for all indicators from government. In a number of instances this means the council is not required to set targets for the first year of the LAA, in others a proxy measure is being used. This is shown in appendix 3.
- 3.1.4 Detailed action plans will be developed for each target. Agencies have been careful to propose targets in the context of resources available, whilst recognising that effective partnership working itself will help to boost performance. This report summarises progress to date on action planning.

3.2 <u>Progress by theme</u>

Children, young people and families

3.2.1 Negotiation has progressed well for this theme, with most targets near to agreement.

Indicator NI 51 effectiveness of child and adolescent mental health service (CAMHS)

This indicator relies on self assessment of the CAMHS service. It is a new indicator but draws in part from data collected previously by the PCT. 3 year targets have been proposed by the PCT which they and the council think are achievable. Medway has made improvement in the last year, from a comparatively poor performance against statistical neighbours. 3 year targets have been proposed by the council which officers believe are achievable – aiming to exceed the average performance of statistical neighbours. 3.2.2 Negotiation has progressed well with this theme with most targets near to agreement. Many of the health targets are also within the new indicator set for the PCT – vital signs – so it has been important to get consistency.

3.2.3 Negotiation had proceeded well, but recently targets where officers believed they had secured outline agreement are being reconsidered by GOSE.

3.2.5 Negotiation on this block has, in part, been slower due to turnover in staff in key posts.

3.3 <u>Conclusions</u>

3.3.1 Although negotiation is not as advanced as officers would like on order to be able to give members a full set of targets for consideration at this stage, progress has been good against an almost impossible national timescale.

4. Diversity Impact Assessment

4.1 Promoting equality and diversity is central to achieving good community cohesion which is a key aim of LAA2, so diversity issues

will be reviewed in all of the action plans developed as a result of the process.

5. Consultation

5.1 The LAA priorities flow from the community plan which was subject to extensive consultation. Where other consultation has been carried out by the council and its partners these results have been used to inform the selection of LAA priorities. There has been extensive involvement of partner organisations in the development of the working list of indicators.

6. Monitoring delivery of the LAA

6.1 The LAA will be monitored through various council, partner and partnership bodies. These arrangements will be subject to later detailed reporting. For clarity at this stage on responsibility within the council appendix 4 shows where the council is lead or supporting agency for the 35 indicators, and allocates targets to portfolio holders and overview and scrutiny committees.

7. Financial and legal implications

- 7.1 The Local Government and Public Involvement in Health Act 2007 places the duty on councils to lead the preparation of the LAA for the area. Government guidance gives the deadline for submission as 30 May 2008.
- 7.2 Action on the targets so far as this relates to the council is, for this financial year, consistent with agreed budgets. Proposals for the future years of the LAA will be considered as part of budget setting.

8. Recommendations

8.1 That Members consider and comment on the performance targets set out in appendices 1-4.
