APPENDIX 2

Statutory Services for Building Control

Disabled person applications

The Partnership will continue to check Building Regulation applications for disabled person adaptations without a fee as required by the Building Act & Building (Prescribed Fees) Regulations

Approved Inspector Register

The partnership will maintain and update the Approved Inspector Register for the public's information

Enforcement

The Partnership will enforce the Building Regulations within the terms of the enforcement concordat. It will also receive and action notices from Approved Inspectors who are unable to gain compliance with the Building Regulations. This will include the dealing with unauthorised work and informing Planning.

Competent Person Schemes

The Partnership will receive and process all competent person notices submitted to the authorities as required under the Building Act

Safety at Sport Grounds (duty requirement for Gillingham Football Club and Northfleet Town).

The partnership will act as the 'Building Authority', as defined under the Safety at Sports Grounds Act, and will attend all meetings, safety inspections and live audits.

Building Regulation Advice

The partnership will provide (not specific to a fee earning application) a helpful, courteous and fast Building Regulation advice service to the local authority, members of the construction industry and the general public.

Response time: Immediately

Fire service liaison

The Partnership will receive and take the appropriate action in response to notification from the Fire Service in relation to modifications to buildings/premises, which will require Building Regulation approval.

Statutory Work for the Local Authority

Dangerous Structures

Provide a 24-hour, 365 day per year service in relation to the inspection of dangerous and ruinous structures, as defined under Sections 77, 78 and 79 of the Building Act 1984.

The Partnership aims to respond to dangerous structure emergency calls within 2 hours.

Demolition

Provide a service in relation to demolition applications, as defined under Sections 80, 81 and 82 of the Building Act 1984.

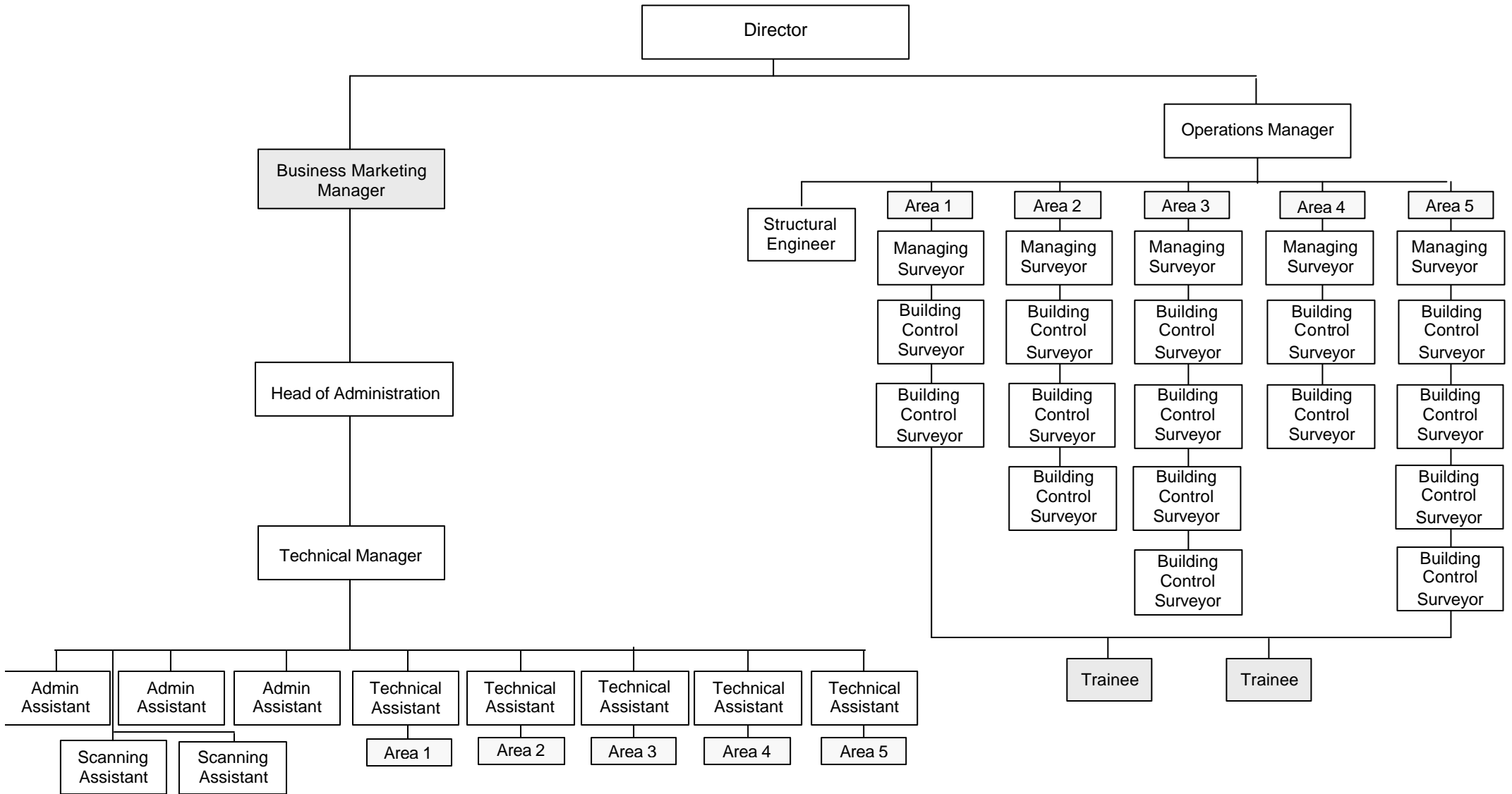
Licensing

Public Events (structure)

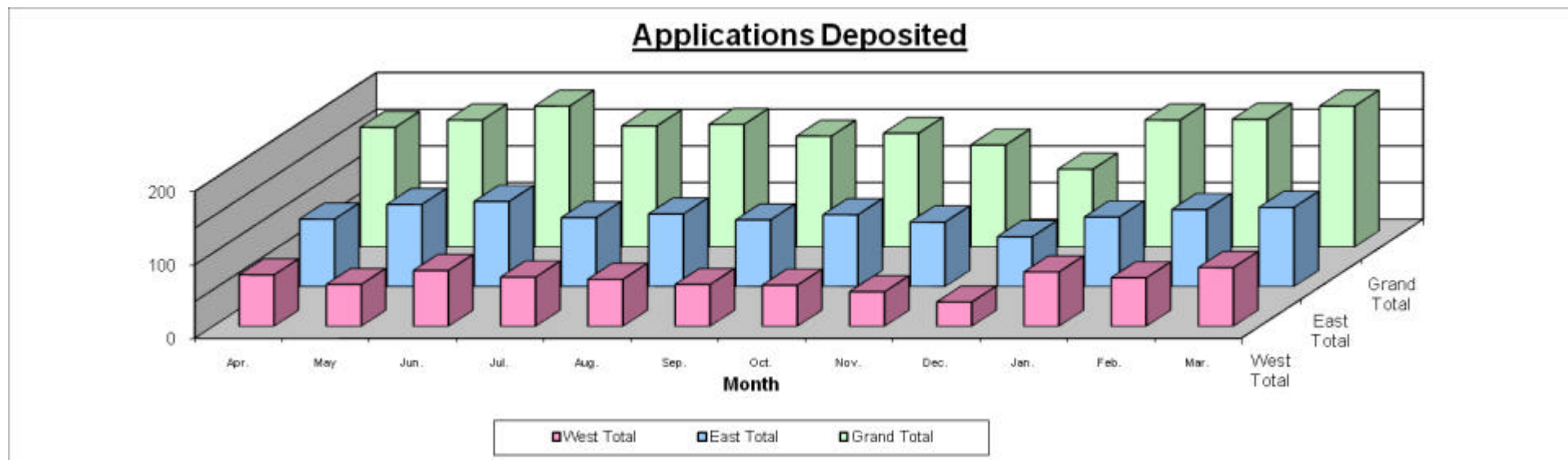
Giving advice on meeting safety standards at public events.

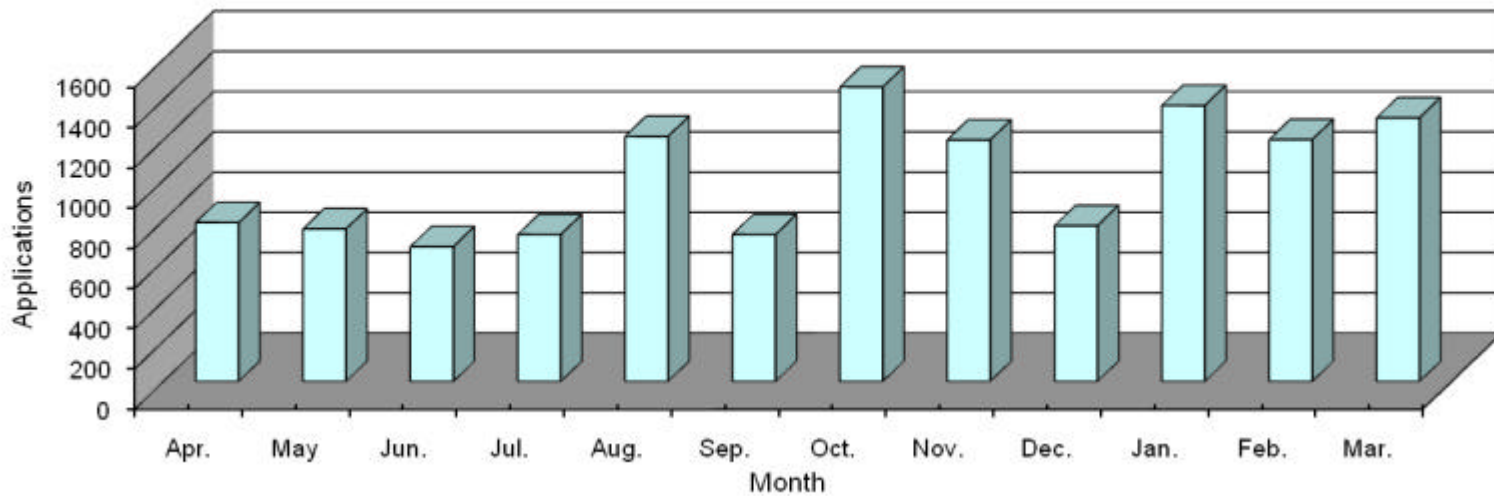

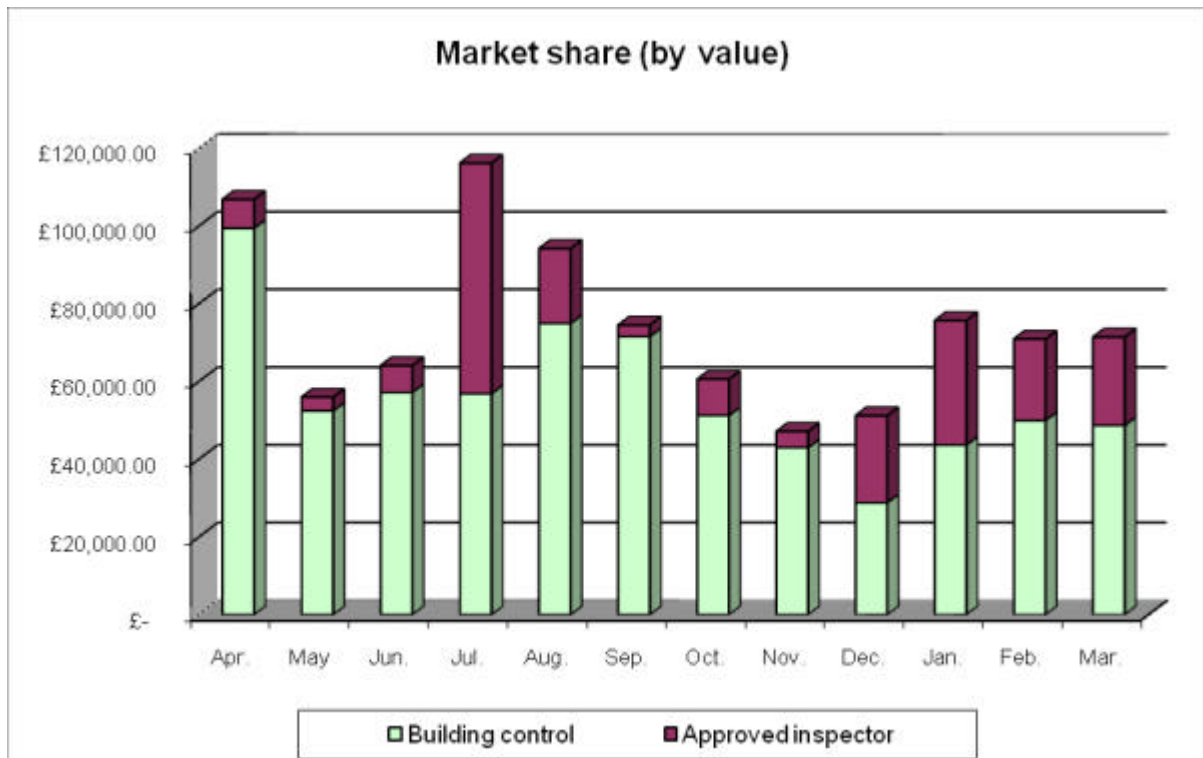
Non-Fee Earning Applications Received 2005 - 2006

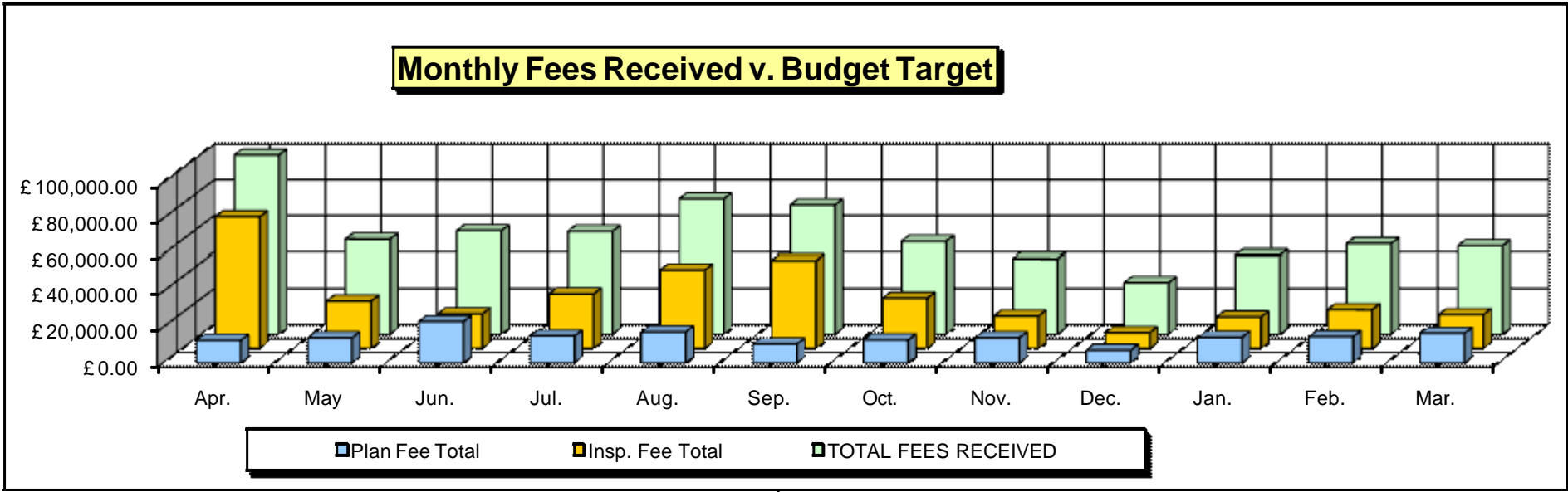
