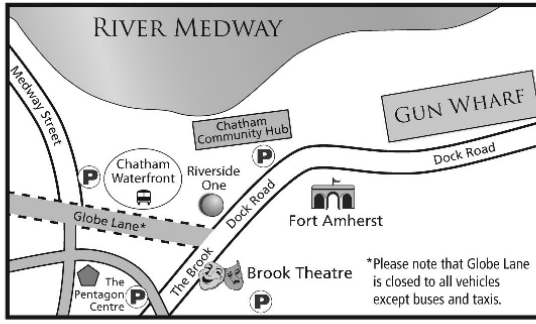

Summary
