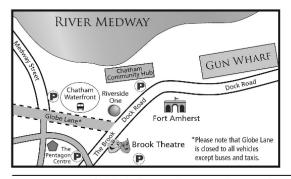

Summary

This addendum report sets out the revised funding allocations after the education skills funding agency reissued the free schools meals data.

1. Background

- 1.1 The funding formula is based on pupil characteristics from the October 2017 census and is supplied by the education skills funding agency (ESFA).
- 1.2 Since the publication of the final funding formula report and the first addendum report, the authority has been advised by the ESFA that incorrect free school meals census data was issued to local authorities in December. Revised census data has now been issued and must be updated and reflected in the funding formula.

2. Revised Funding allocations

- 2.1 There was a change in the free school meals census data, which forms part of the deprivation factor. The lump sum unit cost has been increased by £3,400 to £136,400 to balance the total available funding which affects all 96 schools.
- 2.2 Table 1 below shows the revised funding available for each funding factor after the 2018/19 final funding formula has been "run" and the movement from the initial allocations in the original report.

- 2.3 The final funding formula has distributed:
 - 77.28% through the basic entitlement factors.
 - 96.69% through the pupil lead factors

3. Chief Finance Officer's comments

- 3.1 The change to the free school meals census data does not affect Medway's overall school block dedicated schools grant funding, but it does affect budgets allocated to individual schools.
- 3.2 As there is no change to the funding formula methodology just the census data it is not necessary to resubmit the formula to the Schools Forum for its approval.
