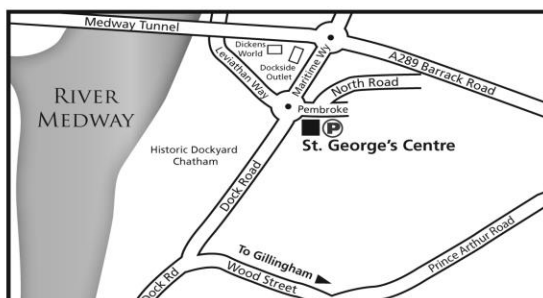

APPOINTMENT OF DIRECTOR OF PLACE AND DESIGNATING THE DIRECTOR OF PEOPLE (CHILDREN AND ADULTS SERVICES) AS DEPUTY CHIEF EXECUTIVE - ADDENDUM REPORT

Summary

This addendum report advises Members of the outcome of the Appointments Committee which met on 17 April 2023 to undertake interviews for the post of Director of Place and also advises on the outcome of the executive notification procedure.

1. Appointments Committee – 17 April 2023
 - 1.1. The Appointments Committee met on 17 April 2023 and interviewed four candidates for the post of Director of Place.
 - 1.2. The Appointments Committee agreed to appoint Adam Bryan to the post of Director of Place.
 - 1.3. The Appointments Committee comprised of Councillors Brake, Curry, Doe, Hackwell (substitute for Councillor Jarrett) and Maple.
2. Executive notification procedure
 - 2.1. The appointment of the Director of Place may only be made where no material or well-founded objection has been made by any member of the Cabinet in accordance with the provisions of Part II of Schedule 1 of the Local Authorities (Standing Orders)(England) Regulations 2001. This is known as the executive notification procedure.
 - 2.2. Following the Appointments Committee on 17 April 2023, Cabinet Members were contacted to find out whether they had any material or well-founded objections to the appointment. Cabinet Members were advised that Adam had demonstrated to the Appointments Committee that he fulfilled the requirements of the role based on his previous experience.

2.3. Members are advised that no Cabinet Members indicated they had any material or well-founded objections to the appointment.

3. Recommendation

3.1. That the Council approves the appointment of Adam Bryan, agreed by the Appointments Committee, as the Director of Place.
