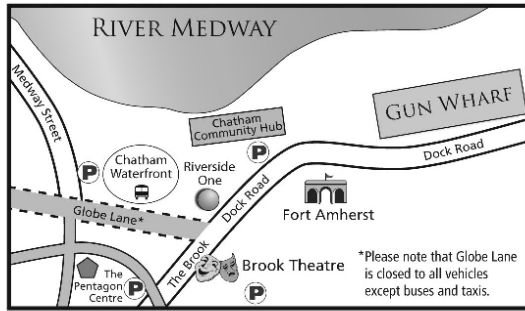

Exclusion of Press and Public

Summary

This report summarises the content of reports which, in the opinion of the proper officer, contains exempt information within three of the categories in Schedule 12A of the Local Government Act 1972. It is a matter for the Panel to determine whether the press and public should be excluded from the meeting during consideration of this item and during the Panel’s deliberations and decision making.

1. Recommendation

- 1.1 The Panel is required to decide whether to exclude the press and public during consideration of the item and during the Panel’s deliberations and decision making because consideration of the matter in public would disclose information falling within three of the descriptions of exempt information contained in Schedule 12A to the Local Government Act 1972, as specified below, and, in all the circumstances of the case, the public interest in maintaining the exemption, outweighs the public interest in disclosing the information.
