

Supplementary Agenda Advice

Minute number 252 - Planning application - MC/23/2793 63 Woodlands Road, Gillingham, Medway, ME7 2DU.

The decision taken by Planning Committee on 28 August 2024, as set out in the minutes, was:

Refused due to the loss of existing parking area and lack of parking for the proposed flats and the lack of private outdoor space.

Final wording to be agreed with the Services Manager – Development Management, Chairperson, Vice Chairperson and Opposition Spokespersons.

The final agreed reasons for refusal were:

The proposed development due to the loss of existing parking area and the lack of parking for the proposed flats would result in an increased pressure on existing on-street parking in an area of high levels of parking stress which would result in an unacceptable impact on highway safety contrary to Policy T13 of the Medway Local Plan 2003 and paragraph 115 of the National Planning Policy Framework (December 2023).

The proposed development fails to provide any private outdoor space for the flats and their future occupiers, which would result in an inadequate level of amenity for those occupiers, contrary to the standards set out in the Medway Housing Design Standards (interim) 2011, Policy BNE2 of the Medway Local Plan 2003 and paragraphs 131 and 135f of the National Planning Policy Framework (December 2023).

Recommendation

Amendment to condition 23 to include "and footpath extension on the Ratcliffe Highway adjacent Pearl Lodge" after traffic calming measures to read as follows:

No more than 50% of the development herein approved shall be occupied until the s278 works including the traffic calming measures and footpath extension on the Ratcliffe Highway adjacent Pearl Lodge have been installed.

Reason: Development without provision of would traffic calming measures is likely to lead to traffic issues and in accordance with Policy T1 of the Medway Local Plan 2003.

Representations

A letter of representation has been received from the Cllr Spalding. The letter examines the traffic data submitted with the application as well as subsequent traffic count data and provides summary information in a spreadsheet (both are attached).

Officer Response

The representation has been examined by the Highway Officer and after consideration concludes that it does not alter the conclusions in the report.

The proposed development is introducing traffic calming in the vicinity of the site, which is a direct response to the development and councillor comments (secured by the amended condition 23 above). The visibility splays for the site access are provided in line with standards, and surveys show the 85th percentile speeds near the access reflect the current speed restriction (and would be expected to fall following introduction of the traffic calming). The actual traffic impact of the proposals would not be expected to be significant.

PREAMBLE

The Ratcliffe Highway runs from the A228 Fenn Street roundabout past the Fenn Bell Public House and Zoo, past Bell Wood on the right up to a group of dwellings known as St Mary's Cottages also on the right.

The speed limit is 40 MPH from the roundabout up to the cottages whereupon the limit drops to 30 MPH.

In the middle of the cottages is another T-Junction with Hall Road on the left hand side. The 40 MPH restriction returns after the cottages.

Ratcliffe Highway continues as a mixture of country lane flanked by woodlands and fields and areas of residential property up to and until it reaches the village of Allhallows.

The road is the primary access route for those visiting and accessing the Haven holiday park in Allhallows. It is also used by farm transport, buses, and of course, local residents.

As ward councillor I have had no input into the dates and locations for the surveys.

Data Analysis

There are three different sets of raw data with differing reporting parameters. In order to produce a common thread for comparison purposes, the data has been analysed and grouped into brackets accordingly.

The groups are 40-45mph, 45-50mph, 50-60mph, 60-70mph and 70-100mph

TRAFFIC REPORT 1 – ESQUIRE DEVELOPMENTS

Esquire developments commissioned a traffic report.

Survey Dates

The survey took place between Saturday 14 October 2023 and Friday 20 October 2023.

Location

It was located after the T-junction of Ratcliffe Highway with Newlands Farm Road and immediately before the entrance to the Industrial Estate located prior to the Fenn Bell Zoo.

Criticism

It would be fair, in my opinion, to criticise both the dates and location of the traffic survey.

Peak traffic flow usually occurs during the summer months when occupation of the Haven holiday park is at its highest with close to ten thousand additional persons in the area and with them comes the additional associated journeys.

Vehicles approaching the T-Junction with Newlands Farm Road and the turning into the Industrial Estate will be in the process of travelling relatively slowly. They are not far from the originating roundabout and therefore have not had time to build up speed. Drivers will also be conscious of the hazards posed by the T-Junction and industrial estate entrance. Furthermore, those vehicles turning into the industrial estate and or Newlands Farm Road will be at very low speed in order to make their turn.

It can therefore be argued, quite correctly in my view, that the data obtained, especially the average speed data is flawed.

Detail

For the seven day period, 6,707 vehicles were recorded travelling North East Bound in excess of the posted speed restriction with 2,945 exceeding the speed limit in the opposite direction.

TRAFFIC REPORT 2 – MEDWAY COUNCIL

Following representations by myself, the ward councillor, at an Overview and Scrutiny committee meeting, a traffic report was authorized for the Ratcliffe Highway using two different locations

Survey Dates

The survey dates were Tuesday 27 February 2024 to Monday 4 March 2024.

Locations

The first was located up from the Fenn Bell Zoo at East Mead opposite the middle of the Bell Wood that flanks the Ratcliffe Highway. The second set of survey lines were opposite Barn Street Farm just before Shakespeare Farm Road.

Criticism

As with the Esquire report criticism of the dates would not be unreasonable for the reasons already given. However, no criticism can be levelled with the locations. Both are in places that would, in my opinion, provide more representative data than that of the Esquire location. However, it would have been useful for additional sets of data strips to have been placed before and after St Mary Cottages where the speed limit is 30 MPH.

Detail

For location one, the seven day period shows, 6,707 vehicles were recorded travelling East Bound in excess of the posted speed restriction with 4,852 exceeding the speed limit in the opposite direction.

For location two, the seven day period shows, 5,086 vehicles were recorded travelling East Bound in excess of the posted speed restriction with 4,8652 exceeding the speed limit in the opposite direction.

TRAFFIC REPORT 3 St MARY HOO PARISH COUNCIL

Following discussions, the parish Council sought its own traffic data report.

Survey Dates

The survey dates were Thursday 9 May 2024 to Sunday 26 May 2024.

Locations

The data strips were positions just before St Mary Cottages on the parish boundary with Allhallows. The speed limit is 30 MPH being reduced from 40MPH for the length of the dwelling cottages.

Criticism

The data period being longer than one week is, in my view beneficial. The dates also include a period when the Haven holiday centre in Allhallows is in operation and starting to get busy. The location, while understandable can be fairly criticised in my view given the absence of a second data report within a stretch of road that is subject to the 40MPH speed restriction.

That said, this report, as is the one commissioned by Medway Council, is dual purpose. Not only does it have a bearing on the planning application but it is also part of an ongoing road safety effort.

Detail

For the period shown, 5,627 vehicles were recorded travelling East Bound in excess of 40 MPH with 5,044 exceeding the speed limit in the opposite direction.

Although the speed restriction here is 30MPH the 40MPH and above bracket is used for consistency considering the other two report.
