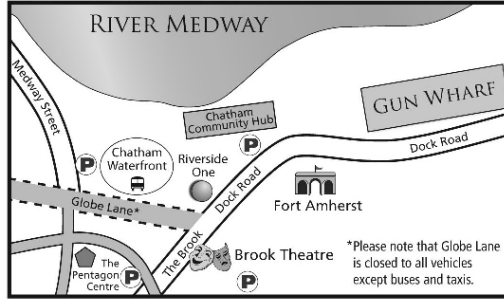

Summary

1. Recommendation
