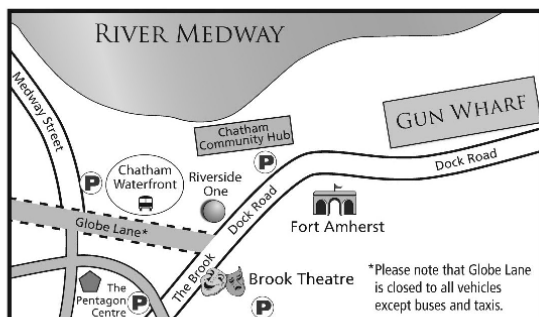
This report recommends to the Planning Committee that enforcement action be taken to resolve a breach of Planning Control at a site in Strood, Rochester.
