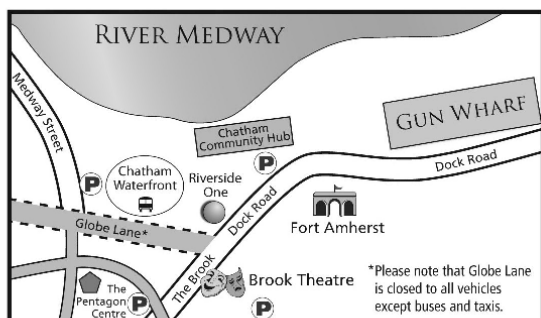
Since the publication of the main agenda, the Premises Licence Holder's representative has submitted the attached proposed conditions and financial information, the latter being exempt information.

PROPOSED CONDITIONS

1. Alcohol shall only be purchased from bona fide suppliers who have been verified as such and where the physical trading address has been confirmed.
2. Upon receipt, invoices for alcohol purchases shall be maintained for inspection at the licensed premises, unless removed for the purpose of reproduction, for a period of 12 months from the date marked on the invoice.
3. After alcohol products have been delivered to the premises, the products shall be subject to scrutiny by a person who has received training on the identification of non-duty paid products. The checks shall include an examination of the labels of a sample of the products, any duty stamps, the fill levels and general appearance of the products.

EXCLUSION OF PRESS AND PUBLIC

Summary

This report summarises the content of the report which, in the opinion of the proper officer, contains exempt information within one of the categories in Schedule 12A of the Local Government Act 1972 as set out below. It is a matter for the Licensing Hearing Panel to determine whether the press and public should be excluded from the meeting during consideration of this document under paragraphs 1 and 3.

It is also recommended that the Panel exclude the press and public from the meeting during the decision making process under paragraph 5.

1. Recommendation

- 1.1 The Licensing Hearing Panel is required to decide whether to exclude the press and public during consideration of a document and during the decision making process because consideration of this matter in public would disclose information falling within one of the descriptions of exempt information contained in Schedule 12A to the Local Government Act 1972, as specified below, and, in all the circumstances of the case, the public interest in maintaining the exemption, outweighs the public interest in disclosing the information.
