# **OUTCOMES OF COUNTER FRAUD INVESTIGATIONS**

### **Summary**

To inform Members of progress in investigating allegations of housing and council tax benefit fraud and other non-benefit fraud. This report covers activity during 2011/12, ending 31 March 2012.

#### 1. Budget and Policy Framework

1.1 Following the Council's decision to establish this committee, it is within the remit of this committee to take decisions regarding accounts and audit issues.

# 2. Background

- 2.1 Medway Council has had a sanction policy since 2002 (revised in 2006) following changes to the way benefit investigations should be conducted. These changes resulted in a more rigorous investigative standard being adopted which lead to specific outcomes, known as sanctions. Namely, that local authorities should consider the use of one of the following courses of action following a successful investigation:-
  - Prosecution
  - Issue of a caution
  - Issue of an administrative penalty (fine)

#### 3. Outcomes of Investigations

- 3.1 The total value of fraudulent overpayments identified by the investigations team in 2011/12 financial year, the investigations team has identified £1.47m of fraudulent overpayments, comprising £804k Housing and Council Tax Benefit and £663K of Department for Work and Pensions (DWP) paid benefits.
- 3.2 In the 2011/12 financial year there were 33 successful prosecutions for benefit offences and these cases are detailed at Annex A. There were also 17 Administrative Penalties and 14 Cautions.
- 3.3 The following table shows the progress of current cases following a decision to prosecute.

Note: these are joint investigations and many of these cases are passed to DWP for prosecution via the Crown Prosecution Service (CPS). Consequently, it is DWP that receives communications from CPS. Therefore, Medway Council does not hold precise dates to analyse these cases.
