Summary

This report asks the Council to consider a provisional programme of meetings for the 2013/2014 municipal year, as set out in the attached appendix, for recommendation to the Council's annual meeting.

1. Budget and Policy Framework

1.1 The programme of ordinary Council and Committee meetings is a matter for formal approval by the Council at its annual meeting in May each year.

2. Background

- 2.1 The Council is being asked to consider a draft programme of Council and Committee meetings for the 2013/2014 municipal year in advance of a decision being made at the annual meeting in May, in order to provide some certainty for Members on the schedule of dates for key meetings during 2013/2014.
- 2.2 The proposed schedule of meetings for 2013/2014 is attached at Appendix A and is consistent with the pattern and frequency of meetings in 2012/2013 approved by the Council last year.
- 2.3 Members are asked to note that the programme of meetings of the Council's Overview and Scrutiny Committees is currently under review and may be subject to change. The Business Support Overview and Scrutiny Committee has a recently agreed a number of areas for further action and development in relation to the Council's Overview and Scrutiny arrangements including a review of the programming and management of business. This is in response to concerns raised by members about the length of meetings and pressure on the programme of business since a reduction from eight to six meetings of each Committee per year as a consequence of reduced staffing capacity in Democratic Services in April 2011. Member level discussion on this and the other areas for further development of overview and scrutiny arrangements will commence at a meeting of the Chairman and Opposition Spokespersons for Business Support Overview and Scrutiny Committee on 31 January 2013.

3. Risk management

3.1 There are no risk management implications arising from this report.

4. Consultation

4.1 Group Leaders and Whips and officers from each Directorate have been consulted on the proposed meetings schedule.

5. Financial and legal implications

5.1 In response to a reduction in staffing capacity in Democratic Services effective from April 2011, the Council agreed a commensurate adjustment in member level meetings and activity including a reduction from seventeen to twelve Cabinet meetings per year and a reduction from eight to six meetings of the Council and its Overview and Scrutiny Committees. Any increase in the overall number of member level meetings could only be achieved with an increase in staffing resources in Democratic Services.

6. Recommendation

6.1 The Council is asked to agree a programme of Council and Committee meetings for 2013/2014 as set out in Appendix A to the report for recommendation to the annual meeting of the Council on 15 May 2013.
