#### Summary

#### 1. Budget and Policy Framework

#### 3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on Thursday 7<sup>th</sup> March 2013.
- 3.2 At the meeting there was a request to programme in scrutiny of progress against the action plan relating to the recent Ofsted report. It was suggested that this be programmed in for September 2013 and March 2014.

#### 4. Cabinet Forward Plan

4.1 The latest forward plan was published on 18 March 2013. There are no items on the forward plan that fall within the remit of this committee that are not scheduled to be considered or have been considered; have been agreed at a previous meeting of this committee that they will not be considered by the committee; or where there is time to consider the item at a future meeting of the committee.

#### 5. Health Scrutiny

- 5.1 To keep Members of this committee informed about key activities relating to the scrutiny of children's health this section provides an update of recent or forthcoming activity for this committee, the Health and Adult Social Care Overview and Scrutiny Committee (OSC) and the shadow Health and Wellbeing Board.
- 5.2 The Health and Adult Social Care Overview and Scrutiny Committee will be considering a report at its next meeting setting out changes to the legislation relating to health scrutiny, which come into effect on 1 April 2013. Members of this committee will be sent a web link to the report when it is published and are invited to attend the committee's meeting on 9 April 2013 if they wish. In summary the legislation extends the scope of health scrutiny and introduces new provisions relating to consultation with Overview and Scrutiny by relevant NHS bodies and health service providers on significant health service reconfigurations. The Council will determine any changes required to health scrutiny arrangements in Medway at its meeting on 25 April 2013.

#### 6. Implications for Looked After Children

6.1 Scrutinising services and support for looked after children (LAC) is a key aspect of the remit of this committee. Members should ensure they focus attention on the Every Child Matters outcomes for LAC as well as scrutinising every child matters outcomes for all children in Medway.

#### 7. Financial and legal implications

- 7.1 There are no financial implications arising from this report.
- 7.2 Local authorities may review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. This Committee has responsibility to discharge the power of health scrutiny in relation to children's health.

#### 8. Recommendations

- 8.1 That, subject to changes made at the meeting, the work programme is agreed as set out at the attached Appendix 1 of the report.
- 8.2 That scrutiny of the progress made with the action plan relating to the recent Ofsted report be added to the work programme for September 2013 and March 2014.
