ROAD AND PAVEMENT RESURFACING SCHEMES

Summary

This report provides a list of Road and Pavement Resurfacing Schemes for 2013/14.

It was agreed at Council on 21 February 2013, that a further £480,000 of funding would be put forward for Road and Pavement schemes. This reports identifies those additional schemes on which the funding will be spent.

1. Budget and Policy Framework

- 1.1 The budget for these works has been agreed by Full Council, therefore the recommendations in this report are for Cabinet to decide.
- 1.2 The decision is within the policy and budget framework and in line with the priority of 'Everyone benefiting from regeneration' as set out in the Council Plan 2013/2015.

2. Background

- 2.1 The Highways Department compile a list of Road and Pavement sites to be resurfaced on an annual basis. The list of sites is restricted by the available and allocated budget. The proposed sites for 2013/2014 are listed in Appendix A.
- 2.2 It was agreed at Council on 21 February 2013 that a further £480,000 of funding would be put forward for additional Road and Pavement schemes. The proposed additional road and pavement sites are listed in Appendix B.
- 2.3 Highways are also seeking to improve the figures for National Indicator 168 (Principal Roads where maintenance should be considered) and National Indicator 169 (Non-Principal classified roads where maintenance should be considered) against the newly approved targets of 6% and 13% respectively.

- 2.4 Each year the Highways Department receive information and requests from Members, Highway Inspectors, members of the public and other external sources detailing roads and pavements that require attention.
- 2.4.1 On an annual basis Medway Council undertake prescriptive road condition surveys as is required by Government to determine National Indicators (NI 168 and NI 169). The results from these very specialised inspections are also processed through a Carriageway Asset Management System (JCAM).
- 2.4.2 Each request is also considered and a visit is made to each site by an experienced Highways Engineer to undertake an objective assessment of the road and pavement condition and usage. The assessment takes into account all visual defects such as cracking, crazing and rutting together with those defects previously recorded by our road-surveying consultant.
- 2.4.3 Each of these sites is then given a priority assessment; a list of roads and pavements needing resurfacing is then drawn up. Cost estimates are prepared for each scheme and a cut off point added to show the extent of the approved budget.
- 2.4.4 The implementation of every proposed scheme is subject to weather conditions, statutory undertakers works, projects and other external influences and may therefore be delayed or postponed until resolved.
- 2.5 Following approval of the schemes the programme of resurfacing works will be procured through the Highways Term Maintenance Contract with VolkerHighways.

3. Options

3.1 The additional list of Road and Pavements sites encompassed within the £480,000 funding as detailed below are split with approximately £250,382 on Road sites and £229,618 on Pavement sites. The options for Cabinet are to agree and approve the selected Road and Pavements sites on each list.

4. Advice and analysis

- 4.1 Highways have invested in a system called J-CAM, (Jacobs Carriageway Asset Management) which takes the UK Pavement management System (UKPMS) data in CONFIRM (highways Asset management system) and enters that data into a model of the councils network, from this model we can predict what resources we need over the coming years to either maintain the network to a predetermined condition or conversely if we specify what resources will be spent on the asset, the model will predict the condition the network will be in over years, so that reliable informed decision making can take place.
- 4.2 This system (JCAM) is currently being calibrated and populated with Medway data and over the coming year will offer significant information on the condition of the roads in Medway to ensure that in future years we will be able to see the condition of all roads/pavements in Medway and will be able to take informed decisions based on technical condition data.

6. Consultation

- 6.1 For all of the resurfacing works there will be prior consultation with transportation companies and emergency services.
- 6.2 For some of the Rainham sites it will be necessary to consult with private property owners regarding works adjacent to the private forecourts in Station Road. The works detailed below are only for those areas that are public Highway and does not extend onto the private forecourts.

7. Financial and legal implications

- 7.1 Road and Pavement Resurfacing schemes 2013/2014 (Appendix A) There are no financial implications resulting from this scheme as the funding has already been allocated through the LTP process and through Members approval of Highway Budgets identified and set at Council in February 2013.
- 7.2 Additional road and Pavement Schemes (Appendix B) There are no financial implications resulting from this scheme as the funding has already been

- allocated through Members approval of Highway Budgets identified and set at Council in February 2013.
- 7.3 Members Priority Fund There are no financial implications resulting from this scheme as the existing Members' Priority Fund will be used to facilitate the implementation of the public highway element of these works.
- 7.4 The Council has a number of duties under the highways legislation, primarily under section 41 of the Highways Act 1980 to maintain adopted highway.

8. Recommendations

- 8.1 The Cabinet agrees the Road and Pavement programmes as set out in Appendices A and B to the report.
- 9. Suggested reasons for decision(s)
- 9.1 The reason for the recommendations are that they will assist with the Council's priority of 'Everyone benefiting from regeneration'.
