INVESTIGATIONS RELATING TO EXTERNAL FRAUD

Report from: Internal Audit

Summary

To inform Members of progress in investigating allegations of external fraud relating to Housing Benefit & Council Tax benefit and discount, Blue Badges and Housing. This report covers concluded cases during the fourth quarter of 2012/13, ending 31 March 2013.

1. Budget and Policy Framework

1.1 It is in the remit of the Audit Committee to take decisions regarding accounts and audit issues.

2. Background

- 2.1 Medway Council has had a sanction policy since 2002 (revised in 2006) following changes to the way benefit investigations should be conducted. These changes resulted in a more rigorous investigative standard being adopted which lead to specific outcomes, known as sanctions. Namely, that Local Authorities should consider the use of one of the following courses of action following a successful investigation:-
 - Prosecution
 - Issue of a "Simple Caution"
 - Issue of an Administrative Penalty (fine)
- 2.2 The Anti Fraud and Corruption Policy, updated 17 August 2012, forms part of the Council's Constitution and sets out the Council's commitment to ensuring the opportunity for fraud and corruption is reduced to the lowest possible risk.

3. Outcomes of Benefit Investigations

3.1 The total value of benefit & discount related fraudulent overpayments identified by the Corporate Anti Fraud Team (CAFT) in 4th Qtr of 2012/13: -

3.6 In the 4th Qtr of the 2012/13 financial year there were 9 successful prosecutions for benefit offences and these cases are detailed at Annex A. There were no Cautions issued and 1 Administrative Penalty.

4. Cheque Fraud

- 4.1 In the process of routine bank reconciliations school staff at one of Medway's schools identified 16 cheques drawn on the school's bank account that had not been issued by the school. This was reported to the bank, police, and the council. The total was confirmed to be £28,071.42. A further two fraudulent payments were then identified by the bank and blocked. The total attempted fraud was therefore £31,564.63.
- 4.2 It is considered likely that a genuine cheque was intercepted in the post (one sent to a London address was not accounted for) and the next range of numbers was used to create fraudulent cheques.
- 4.3 The full amount has been refunded to the school by the bank. There has been no financial loss to the school, we are satisfied with the action taken by management throughout and no further action is necessary.

5. Risk Management, Financial and Legal implications

5.1 There are no risk management, financial or legal implications arising from this report.

6. Recommendations

6.1 Members are asked to note progress in investigating benefit fraud in accordance with the approved Anti Fraud & Corruption policy.
