#### **Summary**

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives Members the opportunity to shape and direct the Committee's activities over the year.

#### 1. Budget and Policy Framework

1.1 Under Chapter 4 – Rules, paragraph 22.1 (v) General terms of reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

#### 2. Background

2.1 Appendix 1 to this report sets out the existing work programme for the Committee.

#### 3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on Tuesday 25 June 2013.
- 3.2 At the meeting it was agreed that Members of the committee be invited to a visit at Aut Evens before consideration of the report on the review of overnight short breaks on 16 July 2013.
- 3.3 At the meeting Members also agreed to add the following items to the committee's work programme: -
  - SEN Disability Pathways
  - Children not in education (to include children who are home educated)
  - Role of school nursing and its impact on keeping children healthy and safe
  - YOT Business Plan

3.4 At the meeting it was also agreed that care leavers and care leavers in employment, education and training should also be scrutinised but that this should be picked up under the forthcoming scrutiny review into preventing looked after children from becoming criminalised.

#### 4. Cabinet Forward Plan

4.1 The latest forward plan was published on 10 June 2013. The following items have been added. At the pre-agenda meeting it was not recommended to add any of these items to the work programme: -

Gateway 1 Contract Procurement Commencement: 3 Sept 2013

Brompton Westbrook Primary School – Expansion to two forms of entry

This Gateway 1 Procurement Commencement report relates to the expansion to two forms of entry for Brompton Westbrook Primary School

Gateway 3 Contract Award: Refurbishment and remodelling <u>3 Sept 2013</u> works at Chatham Primary School

This report will set out the tender review and evaluation in respect of the contract award for refurbishment and remodelling works at Chatham Primary School.

#### 5. Health scrutiny

5.1 The Annual Public Health Report is currently being prepared and will be brought forward to this committee, along with the Health and Adult Social Care Overview and Scrutiny Committee, later in the year. It has therefore been added to the work programme schedule, as attached at the appendix, with date to be determined.

#### 6. Implications for Looked After Children

6.1 Scrutinising services and support for looked after children (LAC) is a key aspect of the remit of this committee. Members should ensure they focus attention on the Every Child Matters outcomes for LAC as well as scrutinising every child matters outcomes for all children in Medway.

#### 7. Financial and legal implications

- 7.1 There are no financial implications arising from this report.
- 7.2 Local authorities have power to scrutinise health service in their areas under the Health and Social Care Act 2001. It describes health scrutiny as "reviewing and scrutinising health service matters and making reports and recommendations to NHS bodies on such matters".

8.1 That, subject to changes made at the meeting, the work programme is agreed as set out at the attached Appendix 1 of the report.


