Proposed amendments to Bus Lane use in Riverside (Canal Road) Strood

Statement of Reasons: -

The members of the Regeneration, Community & Culture Overview & Scrutiny Committee, at Medway Council, wish to review the use of the bus lane in Riverside Strood, as it is believed that by expanding its use to include taxis it may improve Medway's integrated transport system by allowing taxis to better serve Medway City Estate. The proposal may divert Strood Station based taxis from local roads as they journey to Medway City Estate via the High St, Station Rd, Banks Rd and Commissioners Rd (or Frindsbury Rd/Hill). The proposed amended restriction is shown below and we are consulting with you to seek your views on this.

Proposed Restrictions

Restrict use of Riverside / Canal Road (Bus Only Street section) to use by Taxis (to include private hire vehicles) and Local Buses only.
