Summary

A notice of intention to conduct business in private was issued on 30 September 2013. No representations have been received.
- 1.3 With regard to the Gateway 1 Procurement Commencement: Eastgate House Refurbishment Works report, on this occasion it was impracticable to provide this 28 clear days' notice. The Chairman of the Regeneration, Community and Culture Overview and Scrutiny Committees has agreed, in accordance with the provisions of the 2012 Regulations, that this matter is both urgent and cannot be reasonably deferred. This is because to ensure that this project stays on the agreed timetable this includes the Gateway 3 Contract Award report being submitted to Cabinet on 11 February 2014. Any delay at Gateway 1 will cause slippage in the delivery of the project. This report was subsequently published in an update to the current edition of the Forward Plan on 17 October 2013 and no representations have been received.
