Summary

1. Budget and Policy Framework

1.1 Under Chapter 4 – Rules, paragraph 22.1 (v) General terms of reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the existing work programme for the Committee.

3. Agenda planning meeting

3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on Wednesday 20 November 2013.

4. Cabinet Forward Plan

4.1 The latest forward plan of forthcoming Cabinet decisions was published on 18 November 2013. The following items have been added that fall within the remit of this committee:

Expansion of Danecourt Special School

This report will provide details of expansion proposals for Danecourt Special School and to seek Cabinet approval to authorise officers to commence a period of informal consultation on the proposals as part of the statutory process; and the commencement of an options appraisal to consider the most appropriate way to physically expand the premises, within the allotted funding and timeframe.

Gateway 3 Contract Award: Hoo Peninsula

Wireless Network

This report will set out proposals for the award of the procurement of a wireless network solution for schools and academies on the Hoo Peninsula.

A Better Start Big Lottery Bid

This report will set out details of the Big Lottery Bid "A Better Start". The Big Lottery, "A Better Start" programme, aims to improve the physical, emotional and psychological foundations built during a child's first few years.

4.2 At the pre-agenda meeting it was suggested by the Members present that one item that appeared on the Forward Plan published on 2 September 2013 be added to the work programme, this has therefore been considered as an item on the agenda for this meeting:

Outcome of consultation – expansion of Brompton Westbrook Primary School

14 January 2014

This report will set out the outcome of consultation on the proposed expansion of Brompton Westbrook Primary School.

4.3 Furthermore, it was agreed that <u>Early Help Strategy</u> be added to the agenda for the meeting of this Committee on 14 January 2014. This will be appearing on the Forward Plan for consideration by the Cabinet on 11 February 2014.

5. Health scrutiny

- 5.1 At this Committee's meeting on 15 January 2013 it was agreed that more emphasis needed to be placed on the scrutiny of children's health services and it was agreed that a member briefing on children's health issues in Medway would be provided during 2013.
- 5.2 The Annual Public Health Report of the Director of Public Health 2012/13 is an item on the agenda for this Committee meeting. The focus of the report is the health and wellbeing of school aged children. As agreed by this Committee on 26 September a briefing on children's health issues in Medway for all members of this Committee and the Health and Adult Social Care Overview and Scrutiny Committee has been arranged for earlier in the evening on 10 December 2013. This will assist members to explore the key issues arising from the 2012/13 Annual Public Health report and identify issues relating to children's health for further scrutiny and discussion.

6. Election of Parent Governor representative

- 6.1. The Committee has had a vacancy for a voting member to represent parent governors following the resignation of Samantha Collins earlier in the year. Samantha was appointed to the Committee on 20 October 2011 for a four year term expiring in October 2015. Nominations to the vacancy were invited from among parent governors at Medway local authority maintained schools in July and October 2013 but none have been received. The Parent Governor Representatives (England) Regulations 2001 stipulate that where a vacancy remains unfilled because no, or not enough, candidates seek election, the Council shall repeat the process within one year of the original vacancy arising and at six monthly intervals thereafter, calculated from the first anniversary of the original vacancy having arisen, until the vacancy is filled.
- 6.2 Since the last meeting of the Committee, Kwashie Anang, has confirmed he is no longer a parent governor. This potentially gives rise to a second vacancy. Kwashie was appointed to the Committee on 26 July 2012 for a four year term

expiring in July 2016. If an election is required, this has to be held in time for the vacancy to be filled within six months of it occurring. The Committee will be advised of the position at the meeting.

7. Implications for Looked After Children

7.1 Scrutinising services and support for looked after children (LAC) is a key aspect of the remit of this committee. Members should ensure they focus attention on the Every Child Matters outcomes for LAC as well as scrutinising every child matters outcomes for all children in Medway.

8. Financial and legal implications

- 8.1 There are no financial implications arising from this report.
- 8.2 Under The Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council has power to review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. This Committee has the remit to review and scrutinise health services for children and must invite interested parties to comment on particular matters under review or scrutiny and take into account relevant available information and in particular, relevant information provided by Healthwatch Medway. The Committee may make reports and recommendations and reports to relevant NHS bodies or health service providers. These organisations are also under a statutory obligation to consult the Committee on any proposal for a substantial development or variation of children's health services in Medway.
- 8.3 The Parent Governor (England) Regulations 2001 provide for the arrangements relating to the election of voting parent governor representatives to education Overview and Scrutiny Committees.

9. Recommendations

- 9.1 That, subject to any changes made at the meeting, the work programme is agreed as set out at the attached Appendix 1 of the report.
- 9.2 That nominations to vacancies for voting parent governor representatives should be invited in the New Year as appropriate, for a four year term of office.
