Summary

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives Members the opportunity to shape and direct the Committee's activities over the year.

1. Budget and Policy Framework

1.1 Under Chapter 4 – Rules, paragraph 22.1 (v) General terms of reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

2. Background

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 14 May 2014.
- 3.2 At the agenda planning meeting the work programme was considered and a Briefing Note updating Members on schools that are becoming academy schools was requested. This will be circulated to the Committee in the Autumn term.
- 3.3 It was also noted that a report on the Short Breaks Review due to be considered at this meeting of the Committee would now be considered on 18 September 2014.

5. Health scrutiny

5.1 An update on School Nursing was presented to the meeting of this Committee on 14 January 2014 and an update report is programmed for January 2015.

6. Election of Parent Governor representatives

6.1. There are currently two voting member vacancies to represent parent governors on this Committee. The first vacancy occurred on 26 June 2013 and the second vacancy was announced at the meeting of this Committee on 10 December 2013.

- 6.2. In accordance with the Parent Governor (England) Regulations 2001, in July 2013 and October 2013 nominations were invited to the initial vacant position from parent governors of maintained schools. No nominations were received.
- 6.3. An election process for both vacant parent governor places commenced again in February 2014, with nominations closing on 7 March 2014. Two nominations were received. One was not eligible as the nominee was not an elected parent governor on the school governing body and the other nominee withdrew as the school where they are a parent governor is considering becoming an academy school.
- 6.4. Invitations for nominations to the two vacant positions will need to be repeated within one year of the original vacancy having arisen and then at six monthly intervals thereafter until the vacancies are filled. As we have advertised parent governor vacancies 3 times in the last 12 months, it is proposed that the next nomination and election process commences in September 2014 to coincide with school term dates, and that the process be repeated in Spring 2015 if the vacancies are not filled.

7. Implications for Looked After Children

7.1 Scrutinising services and support for children who are looked after is a key aspect of the remit of this Committee. Members should ensure they focus attention on the Every Child Matters outcomes for children who are looked after as well as scrutinising every child matters outcomes for all children in Medway.

8. Financial and legal implications

- 8.1 There are no financial implications arising from this report.
- 8.2 Under The Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council has power to review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. This Committee has the remit to review and scrutinise health services for children and must invite interested parties to comment on particular matters under review or scrutiny and take into account relevant available information and in particular, relevant information provided by Healthwatch Medway. The Committee may make reports and recommendations and reports to relevant NHS bodies or health service providers. These organisations are also under a statutory obligation to consult the Committee on any proposal for a substantial development or variation of children's health services in Medway.
- 8.3 The Parent Governor (England) Regulations 2001 provide for the arrangements relating to the election of voting parent governor representatives to education Overview and Scrutiny Committees.

9. Recommendations

9.1 The Committee are asked:

- (a) to agree the work programme as set out at the attached Appendix 1 of the report, subject to any changes made at the meeting;
- (b) to note that a Briefing Note on schools obtaining Academy status in Medway will be circulated to the members of this Committee for information in September;
- (c) to note that a further election process for nominations for Parent/Governor Representatives will commence in September 2014.
