# **CABINET ADVISORY GROUPS**

#### Summary

The Cabinet is asked to agree to the establishment of the Cabinet Advisory Groups for 2014/2015.

#### 1. Budget and Policy Framework

1.1 The establishment and appointment to Cabinet Advisory Groups is a matter for Cabinet.

#### 2. Background

- 2.1 The Cabinet has established a number of Advisory Groups to assist in the key areas of corporate parenting, the local development framework, the local transport plan, regeneration and the Council's procurement arrangements. Details of these are set out below.
- 2.2 These groups have no decision-making powers and consist of both executive and non-executive Councillors. In some instances they also include external representatives.
- 2.3 In 2009 the Cabinet agreed to delegate authority to the Chief Executive to make any in-year changes to the membership of the Cabinet Advisory Groups as necessary, in consultation with the Group Whips. This report requests that Cabinet agree to the establishment, size and nominations to these groups for 2014/2015.

#### 3. Airport Proposals Cabinet Advisory Group

3.1 The Cabinet agreed to set up a cross party Cabinet Airport Advisory Group with the aim of advising on the Council's strategy for joining with others to oppose plans for Thames Estuary Airports at its meeting on 20 December 2011.

- 3.2 Further to this, Council on 12 January 2012, reaffirmed its strong opposition to the current plans to construct any of the new International Airport proposals in, or close to, Medway and agrees to work with neighbouring authorities, local communities, businesses and environmental groups to oppose these proposals.
- 3.3 This is a cross-party Group on a 5:3:1 basis and is supported by the Director of Regeneration, Community and Culture together with other senior officers.
- 3.4 It is recommended that the Cabinet approve the reestablishment of the Airport Proposals Cabinet Advisory Group, as set out in appendix 1 to the report.

#### 4. Chatham Regeneration Board

- 4.1 On 27 November 2012 the Cabinet agreed to re-establish a Chatham Regeneration Board. This decision was taken to respond to a number of changing circumstances.
- 4.2 The remit of this group is to:
  - keep under review strategies to regeneration of Chatham
  - coordination of regeneration initiatives, projects and funding streams related to Chatham Regeneration
  - pursue external funding opportunities
  - ensure all appropriate development opportunities are appraised and pursued as appropriate
  - progress development of Queens Street and Chatham Waterfront sites as appropriate.
  - Ensure a positive message re Chatham Regeneration is effectively communicated.
- 4.3 This is a cross-party Group consisting of the Leader, Portfolio Holders and a representative of both Chatham Central and River Wards. It is supported by the Regeneration, Community and Culture Directorate.
- 4.4 It is recommended that the Cabinet approve the reestablishment of the Chatham Regeneration Board, as set out in appendix 1 to the report.

#### 5. Children and Adults Capital Programme Cabinet Advisory Group

- 5.1 The Children and Adults Capital Programme Cabinet Advisory Group was established in 2011 to review, analyse and scrutinise progress on the Children and Adults capital programme.
- 5.2 The Board is chaired by the Portfolio Holder for Children's Services with the Portfolio Holders for Adult Services and Finance, together with the Director of Children and Adults Services and senior council officers including representatives of finance, legal and procurement services.
- 5.3 It is recommended that the Cabinet approve the reestablishment of the Children and Adults Capital Programme Cabinet Advisory Group, as set out in appendix 1 to the report.

#### 6. Corporate Parenting Board

- 6.1 Medway Council is the corporate parent of the children in its care, wherever the children are placed. All Councillors have a responsibility in fulfilling this role. Medway has decided to exercise the function of corporate parenting through a Corporate Parenting Group.
- 6.2 The Cabinet in 2003 agreed to the establishment of a corporate parenting steering group, to advise officers on policy relating to looked after children monitor performance and celebrate and share achievements. Following the Joint Area Review the group was reconfigured and has now become an advisory group chaired by the Portfolio Holder for Children's Services. The group (now to be known as the Corporate Parenting Board) examines how Medway Council is meeting its obligations to Looked after Children in terms of providing care, a home and access to health and education and doing all the other things a good parent does.
- 6.3 Reflecting the responsibility for all Councillors in this area it is proposed that the group comprises representatives from all the political groups on the council. The officers who usually attend meetings are the Director of Children and Adults, the Assistant Director for Children's Social Care, the Service Manager for Looked After Children, the Virtual Head teacher as well as representatives from the Police, NHS and Medway Youth Trust.
- 6.4 It is recommended that the Cabinet approve the establishment of the Corporate Parenting Board, as set out in appendix 1 to the report.

#### 7. Development Plans Advisory Group

- 7.1 In May 2004 the Cabinet agreed to the establishment of a Local Development Framework Advisory Group comprising of two Cabinet Members and three Members of the then Environment and Front Line Services Overview and Scrutiny Committee.
- 7.2 Consisting of officers and Council Members the group was established to report on day-to-day details and also local development documents and public participation before reports were presented to Cabinet or Overview and Scrutiny. It is now proposed to rename this body as the Development Plans Advisory Group to better reflect the work the Council is currently undertaking in this area.
- 7.3 It is recommended that the Cabinet approve the establishment of the Development Plans Advisory Group, as set out in appendix 1 to the report.
- 7.4 The Group will also provide steers/advice to officers regarding the preparation of any revisions to the Developers' Guide or to any Community Infrastructure Levy.

#### 8. International Economic Development Cabinet Advisory Group

- 8.1 On 30 October 2012 the Cabinet considered a report that sought approval to revised terms of reference for the former International Relations Cabinet Advisory Group.
- 8.2 The Cabinet had established the International Relations Cabinet Advisory Group in June 2012 and the group had considered its role and existing terms of reference. It was agreed that the group would focus on economic development and international inward investment, and former responsibilities for 'twinning and ceremonial activities' and 'student exchanges' were passed to the Mayor's Office and officers within the Children and Adults directorate respectively.
- 8.3 The Group's Terms of Reference are as follows:
  - Building long term confidence and investment/economic / trade relationships with international cities.
  - Responding appropriately and in a focused way to interest and delegations from business/investment groups from outside the UK.
  - Utilising the council's economic development website to encourage Medway's international trade links.
  - Seeking external funding (e.g. Interreg) to promote international trade and business in Medway.
  - Developing international trade in university related research, innovation (including promoting an innovation corridor in Europe), port and logistics etc.
  - Ensuring that Medway's economic development strategies include an international focus.
  - Strengthening existing economic development related links with Chancheng (China) and Tallinn (Estonia) and enable Medway to respond to investment opportunities, which present themselves.
- 8.4 It is recommended that the Cabinet approve the reestablishment of the International Economic Development Cabinet Advisory Group, as set out in appendix 1 to the report.

#### 9. Local Transport Plan Advisory Group

- 9.1 In November 2009 the Cabinet agreed to the establishment of a Cabinet Advisory Group to assist with the development of the Local Transport Plan.
- 9.2 On 3 March 2011 Full Council approved the Local Transport Plan (LTP) 3, which set out Medway's Transport Strategy for the next 15 years. This followed consideration at Cabinet on 15 February 2011.
- 9.3 At the Cabinet meeting on 15 February 2011 the work of the group to help steer the development of the LTP3 Transport Strategy was reported. The Cabinet also agreed that the LTP Advisory Group should continue to meet during the early stages of LTP3 (decision number 27/2011). This would be to oversee the implementation of the strategy.

9.4 It is recommended that the Cabinet approve the reestablishment of the Local Transport Plan Advisory Group, as set out in appendix 1 to the report.

#### 10. Procurement Board

- 10.1 The Procurement Board was originally established in 2006 when the Council replaced its value based procurement process with a new risk based gateway process.
- 10.2 In October 2010 the Council agreed changes to the Contract Procedure Rules and the Council's procurement framework to ensure that the processes were more streamlined, whilst remaining robust. These took effect from 1 January 2011. This process includes the Procurement Board that reviews, analyses and scrutinises procurement activity across the Council with a view to ensuring the provision of best value goods, services and works.
- 10.3 The Procurement Board consists of two Portfolio Holders, together with the Monitoring Officer, Chief Finance Officer, Assistant Director Organisational Services, Procurement representative and other key representatives from each of the council's respective directorates.
- 10.4 It is recommended that the Cabinet approve the reestablishment of the Procurement Board with the Board being chaired by the Portfolio Holder for Finance, together with the Portfolio Holder for Adult Services, as set out in appendix 1 to the report.

# 11. Regeneration, Community and Culture Capital Programme Cabinet Advisory Group

- 11.1 The Regeneration, Community and Culture Capital Programme Cabinet Advisory Group was established by Cabinet in June 2012 to review, analyse and scrutinise progress on the Regeneration, Community and Culture capital programme, on a similar basis to the Children and Adults Capital Programme Cabinet Advisory Group, as outlined earlier in the report.
- 11.2 The Group is chaired by the Portfolio Holder for Front Line Services and also includes the Portfolio Holders for Finance and Housing and Community Services. The Group also consists of the Director of Regeneration, Community and Culture and senior council officers including representatives of finance, legal and procurement services.
- 11.3 It is recommended that the Cabinet approve the reestablishment of the Regeneration, Community and Culture Capital Programme Cabinet Advisory Group, as set out in appendix 1 to the report.

### 12. Financial and legal implications

- 12.1 There are no direct financial implications arising from this report.
- 12.2 Requirements under the Local Government and Housing Act 1989 concerning political proportionality do not apply to these advisory groups. It is a matter for Cabinet to establish and/or remove such groups as appropriate, as well as determine their size and composition.

#### 13. Risk management

13.1 There are no risk management implications arising from this report.

#### 14. Recommendation

14.1 The Cabinet is asked to agree the establishment of the Cabinet Advisory Groups with the terms of reference set out in this report and appointment of Members to these bodies, as set out in appendix 1 to the report, for 2014/2015.

## 15. Suggested reasons for decisions

15.1 The establishment of these groups will support the Cabinet in decision-making and the development of policies.
