**Action Plan 2013/14 Update** 



## **Priority 1 – Tackle Substance and Alcohol Abuse**

Retender drug and alcohol treatment services to better meet the need of the population	Fully consulted specification agreed and awarded	Contract was awarded to Turning Point on 7 April. Tender process was made up of 3 stages: written submission, presentation and interview with service users and presentation and interview with commissioners (commissioners included probation, public health and DAAT). A 3-month transition is now under way - Turning Point commence new integrated drug and alcohol service on 1 July 2014.
To increase the proportion of adult clients who successfully complete drug treatment	Increase from 33% to 45%	There is an issue with this target, which has become apparent since our data was published in Q2. We used to receive information on the number of successful completions as a proportion of those who leave treatment (i.e. a measure of how many clients leave treatment services in a planned way rather than drop out). However PHE is no longer providing this detail – we now receive data on the number who successfully complete as a proportion of all in treatment. This means the denominator is now significantly bigger so we will never achieve the 45% target set. Looking at the Public Health Outcome Framework measure for opiate and non-opiate users – Medway has a rate which is marked "similar" to England averages.

Evaluation being finalised in agreement with CCG (who will be responsible for project funding if outcomes are successful after two years). Recruitment to nursing posts is under way.
Improved early identification and prevention of alcohol related harm	IBA training (including links to domestic abuse) delivered to 100 front line staff.	240 frontline staff trained to deliver IBA including social care staff, pharmacists, sexual health staff, health visitors, disability teams and children's services.
