TOPICS FOR IN-DEPTH SCRUTINY REVIEWS – PRIORITIES AND TIMETABLE

Summary

This report invites the Committee to discuss and agree a timetable and process for the selection of topics for the next round of in-depth scrutiny reviews.

1. Budget and Policy Framework


- 1.1 The Council's Constitution states that each Overview and Scrutiny Committee is responsible for setting its own work programme, which should take into account the wishes of all Members of the Committee.
- 1.2 The Business Support Overview and Scrutiny Committee has within its remit the provision of guidance and leadership on the development and co-ordination of the scrutiny function for all Overview and Scrutiny Committees, including guidance on priorities for scrutiny activities.

2. Background

- 2.1 In June 2011 the Business Support Overview and Scrutiny Committee agreed to exercise a more pro-active role than previously in prioritising the programme of indepth scrutiny review work. This was in light of a Council decision that a maximum of three in-depth reviews via Task Groups or themed Committee meetings could be undertaken annually following a reduction in posts within Democratic Services.
- 2.2 The programme of in-depth reviews since 2011 is attached at Appendix 1. The second round of reviews selected under the new process and due to conclude at the end of 2014 included a Task Group on Housing: Demand, Supply and Affordability. Due to some slippage in the timescale for completion of the other reviews in the last round of reviews it was unanimously agreed at the Business Support Overview and Scrutiny Committee on 3 February 2015 to recommend that this should be the first Task Group to be established after the election.

2.3 At the same time as the introduction of a restriction in the number of scrutiny indepth reviews a more systematic and criteria based process was adopted by Members for the selection of review topics. This reflects national best practice and is summarised below and in Appendix 2:

3. Process and timetable for selection scrutiny in-depth review topics

- 3.1 Members are asked to agree that the first Task Group in the post-election period should undertake an in-depth review into Housing: demand, supply and affordability as recommended at the last meeting of the Committee on 3 February 2015. This would be a cross-cutting review covering housing strategy and services which are within the remit of this Committee as well as the strategic planning issues associated with housing such as the Local Plan and affordable housing targets which fall within the remit of the Regeneration, Community and Culture O & S Committee. Therefore, ideally membership of the Task Group should be drawn from both Committees with the final recommendations going back to both Committees before referral to Cabinet. Members are asked to agree that the Task Group should start its work in late August/early September following conclusion of the post-election Member Induction programme and the school holidays.
- 3.2 Members are also recommended to follow the established process for the selection of further topics for the next round of scrutiny in-depth review topics as this has worked well since 2011. The timetable for this would be as follows:

- (i) June -August Each Overview and Scrutiny Committee to be notified of the proposed timetable and process for the determination of the next round of in-depth reviews and Members invited to submit suggestions for topics taking into account the criteria adopted for the selection of reviews (as set out above);
- (ii) August to end September Overview and Scrutiny Committee Chairmen, Vice Chairmen and Opposition Spokespersons use their pre-agenda meetings with officers to propose topics to be put forward and then each Overview and Scrutiny Committee will consider and agree topics to be put forward to this Committee on 3 December.
- (iii) Late October All O&S Chairmen, Vice-Chairmen and Opposition Spokespersons meet informally to prioritise two of the topics put forward by the O and S Committees to be recommended to the Business Support O and S Committee.
- (iv) **3 December** The Business Support Overview and Scrutiny Committee considers and agrees a programme of two in-depth reviews for the period January to September 2016 based on an indicative timescale of 20 weeks for each review.

4. Consultation

4.1 Members of each Overview and Scrutiny Committee will be able to contribute suggestions for topics to be included in the programme of scrutiny in-depth review work.

5. Risk Management

5.1 Risk management is an integral part of good governance. The Council has a responsibility to identify and manage threats and risks to achieve its strategic objectives and enhance the value of services it provides to the community.

6. Financial and Legal Implications

- 6.1 There is a budget of £5210 within Democratic Services to support activity associated with in depth scrutiny review work in this financial year. This can be used for member level visits, expenses claims from those invited to give evidence, expert advice and support with community engagement and other expenditure.
- 6.2 There are no direct legal implications arising from this report.

7. Recommendations

- 7.1 The Committee is asked to agree that a Task Group on housing: demand, supply and affordability in Medway should be the first to commence in late August/ early September 2015 and that the membership of this Group should be five Councillors (in the ratio 3:1:1) to be drawn from this Committee and the Regeneration, Community and Culture O & S Committee.
- 7.2 The Committee is asked to agree the process and timetable for the selection of the next round of in-depth reviews as set out in paragraph 3.2 of the report

Reason for Review

In April 2013 the Business Support Overview and Scrutiny Committee agreed to include a review of the demand, supply and affordability of Housing in Medway in the programme of in-depth reviews agreed at that time. In discussing the possible scope of this review. Members emphasised the key social and economic role that housing plays, particularly for those who are struggling to access affordable housing. On 3 February 2015 the Committee was advised that it would not be possible to start and conclude the work of the Task Group before the local elections on 7 May. The Committee agreed to recommend that this Task Group should be the first one established in 2015/16.
