Summary

This item advises members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives members the opportunity to shape and direct the Committee's activities over the year.

1. Budget and Policy Framework

1.1 Under Chapter 4 – Rules, paragraph 22.1 (v) General terms of reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 25 June 2015.
- 3.2 At the meeting it was suggested that in relation to the item on the forward plan relating to sufficiency of secondary school places (detailed below), this information be provided to the committee members via a briefing note.
- 3.3 At the meeting the Members and the Director of Children and Adult Services also discussed the work programme and a number of suggestions put forward by officers for the committee's consideration. The suggestions that were made included: -
 - Support for Care Leavers Task Group progress update to be scheduled for January 2016

- Integrated Family Support to be scheduled for March 2016
- Early Help Offer to be scheduled for March 2016
- Annual report from Children's Safeguarding Service to be scheduled for September 2015
- Update on Corporate Parenting (including Virtual School) and health assessments for Looked After Children – to be scheduled for September 2015 if not included in the annual report from Children's Safeguarding Service
- Update on Children Centres and Early Years to be scheduled for December 2015
- Integrated Youth Support Services date to be determined.
- Test an examination results for 2015 to be scheduled for March 2016 (once all results have been validated a recommendation from Ofsted)

4. Cabinet Forward Plan

- 4.1 The latest Forward Plan of forthcoming Cabinet decisions was published on 6 July 2015. http://democracy.medway.gov.uk/mgListPlans.aspx?RPId=115&RD=0&bcr=1
- 4.2 Set out below is a list of items featuring on the Forward Plan that fall within the terms of reference of the Children and Young People (CYP) Overview and Scrutiny Committee. The Committee is asked to identify any items it wishes to consider before the Cabinet decision is taken (where dates permit), other than those already programmed in Appendix 1:

5. Selection of next round of scrutiny Task group topics

- 5.1 On 25 June 2015 the Business Support Overview and Scrutiny Committee agreed the process for selection of topics for the next round of in-depth reviews to be undertaken by Overview and Scrutiny Task Groups. A total of three indepth reviews can be supported annually on the basis of the Task Groups running successively, each with a 20 week programme of activity.
- 5.2 It has been unanimously agreed by the Business Support Overview and Scrutiny Committee that the first Task Group in the 2015/16 municipal year should undertake an in-depth review into Housing: Demand, Affordability and Supply. This topic was selected for the last round of in depth reviews and was delayed because it could not have concluded its work before the local elections in May 2015. This Task Group will be cross-cutting covering housing strategy and services, which are within the remit of the Business Support Overview and Scrutiny Committee as well as the strategic planning issues associated with housing such as the Local Plan and affordable housing targets which fall within

the remit of the Regeneration, Community and Culture Overview and Scrutiny Committee. Therefore, it has been agreed that membership of the Task Group (on the basis of 3 x Conservative : 1 x Labour and 1 x UKIP) should be drawn from both Committees with the final recommendations going back to both Committees before referral to Cabinet. The Task Group will start its work in late August/early September following conclusion of the post-election Member Induction programme and the school holidays.

- 5.3 During July, August and September, in line with established practice, it has been agreed that each overview and scrutiny committee should be invited to put forward suggestions for further Task Group topics using the criteria based approach adopted by the Council as set out **in Appendix 2** to this report. Following this an informal discussion between all Overview and Scrutiny Committee Chairmen, Vice Chairmen and Opposition Spokespersons will take place and then the Business Support Overview and Scrutiny Committee will consider the long list of topics at its meeting on 3 December and agree a programme of two reviews for the period January to September 2016 based on an indicative timescale of 20 weeks for each.
- 5.4 Members are invited to submit ideas and suggestions to the Democratic Services Officer ahead of the agenda planning meeting (scheduled for 9 September 2015) for the next meeting of this Committee. These will then be reported back to the next meeting of this Committee.

6. Care Quality Commission Inspection Programme for Mental Health Services

- 6.1. The Care Quality Commission visit of Sussex Partnership Foundation NHS Trusts took place during January 2015. The results were circulated in draft form on 18 May 2015. CAMHS services were inspected in Sussex, Hampshire and Kent, including the Medway & Swale Team, which provides the CAMHS Tier 3 provision for Medway. The overall ratings were given by CQC as:
 - Safety Rating: Requires improvement
 - Effectiveness Rating: Requires improvement
 - Caring Rating: Outstanding
 - Responsiveness Rating: Requires improvement
 - Leadership Rating: Good
 - Overall Rating: Requires Improvement.
- 6.2 The CQC inspection picks up the issue of long waits for treatment following assessment, which was the subject of the letter to CQC written on behalf of the Committee by Cllr Royle on 13 January 2015, and taken up directly at our meeting with CQC inspector on 9 January 2015. This issue is highlighted in two of the required improvement ratings (Safety and Response) but the improvement actions set out in the CQC draft inspection report does not directly address this matter.

7. Implications for Looked After Children

7.1 Scrutinising services and support for children who are looked after is a key aspect of the remit of this Committee. Members should ensure they focus attention on the Every Child Matters outcomes for children who are looked after as well as scrutinising every child matters outcomes for all children in Medway.

8. Financial and legal implications

- 8.1 There are no financial implications arising from this report.
- 8.2 Under The Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council has power to review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. This Committee has the remit to review and scrutinise health services for children and must invite interested parties to comment on particular matters under review or scrutiny and take into account relevant available information and in particular, relevant information provided by Healthwatch Medway. The Committee may make reports and recommendations and reports to relevant NHS bodies or health service providers. These organisations are also under a statutory obligation to consult the Committee on any proposal for a substantial development or variation of children's health services in Medway.
- 8.3 The Parent Governor (England) Regulations 2001 provide for the arrangements relating to the election of voting parent governor representatives to education Overview and Scrutiny Committees.

9. Recommendations

- 9.1 The Committee are asked to agree:
 - (i) the work programme as set out at the attached Appendix 1 of the report;
 - (ii) to receive a briefing note in October relating to the sufficiency of secondary school places
 - (iii) the additions to the work programme, as set out in paragraph 3.3
- 9.2 The Committee Members are invited to submit ideas and suggestions to the Democratic Services Officer ahead of the agenda planning meeting (scheduled for 9 September 2015) for the next meeting of this Committee scheduled for 22 September 2015.

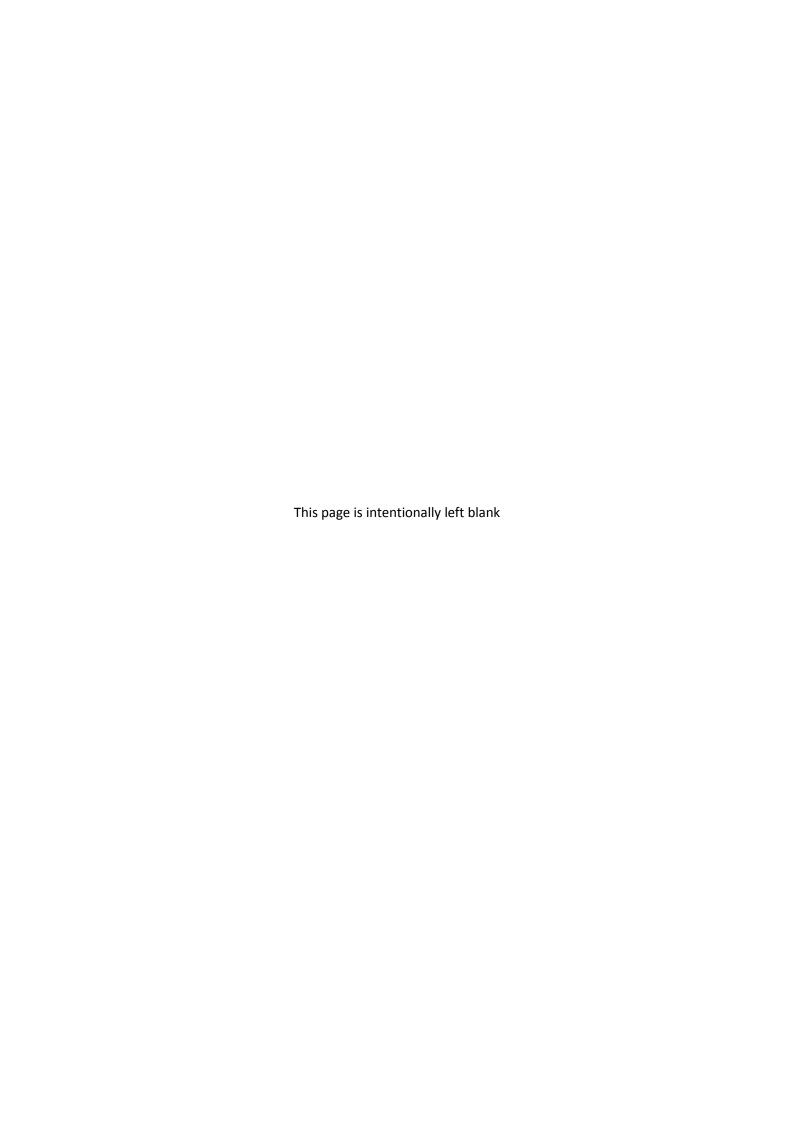

Business Support Overview and Scrutiny Committee – (Topic 1 of x)

Reason for Review

In April 2013 the Business Support Overview and Scrutiny Committee agreed to include a review of the demand, supply and affordability of Housing in Medway in the programme of in-depth reviews agreed at that time. In discussing the possible scope of this review. Members emphasised the key social and economic role that housing plays, particularly for those who are struggling to access affordable housing. On 3 February 2015 the Committee was advised that it would not be possible to start and conclude the work of the Task Group before the local elections on 7 May. The Committee agreed to recommend that this Task Group should be the first one established in 2015/16.
