# CHANGES TO STERLING HOUSE GP SURGERY, CHATHAM

## **Summary**

This report is to inform the Committee of changes relating to Sterling House GP Surgery. The surgery is managed by College Health Ltd and they have recently given notice on their GP contract. The Committee have been invited by NHS England to comment on this issue.

#### 1. Budget and Policy Framework

1.1 Under the Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council may review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. In carrying out health scrutiny a local authority must invite interested parties to comment and take account of any relevant information available to it, and in particular, relevant information provided to it by a local Healthwatch. The Council has delegated responsibility for discharging this function to this Committee and to the Children and Young People's Overview and Scrutiny Committee as set out in the Council's Constitution.

## 2. Background

- 2.1 Attached to this report as Appendix A is a letter from NHS England detailing the changes to Sterling House GP Surgery and the action NHS England is taking in relation to the termination of the GP contract between College Health Ltd and the surgery.
- 2.2 NHS England have invited the committee to comment on this issue and an extension to the deadline for comments has been negotiated with NHS England to allow the committee to comment on this at its August meeting.

I am writing to inform you about some important changes to Sterling House GP Surgery. This surgery is managed by College Health Ltd and they have recently given notice on their General Practice contract.

This means that College Health's contract to provide GP services to patients at the Sterling House Surgery will end on 30 September 2015.

The purpose of this letter is firstly to assure you that NHS England's priority is to guarantee that patients have continued access to a full range of GP services and care after this date and we are now working with the CCG and local practices to identify the best available options for patients and the rest of the community.

However there is the possibility that patients will be required to register with a new GP practice but NHS England can assure you that patients will be given plenty of notice and support if this is the case. Therefore NHS England would like to you the opportunity to express any concerns or issues you may have in regards to this in order that this can be considered as part of the final decision making process. Should you therefore wish to comment please respond to the email above by 7 August 2015.

We have written to all of the patients at Sterling House Surgery advising them of this situation and providing them with an opportunity to raise any concerns or issues about the closure of Sterling House Surgery, which will be feed into the final decision making process. All patients will be contacted again in August once we have completed our review and have a definite outcome regarding the future provision of GP services to their local community.

Please note that Sterling House Surgery will continue to provide services to patients until 30 September 2015.
