Summary

This report advises Members of the current work programme for discussion in the light of latest priorities, issues and circumstances. This report gives Members the opportunity to shape and direct the Committee's activities.

1. Budget and Policy Framework

1.1 Under Chapter 4 – Rules, paragraph 22.1 (v) General Terms of Reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the existing work programme for the Committee.

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. An agenda planning meeting was held on 24 July 2015 and the following was agreed:
 - A briefing note on the letter from NHS England to Medway Clinical Commissioning Group (CCG) which has halted the urgent care review to be circulated
 - Care Quality Commission (CQC) report regarding Kent and Medway NHS and Social Care Partnership Trust to be added to the 1 October meeting
 - CQC report regarding Medway NHS Foundation Trust (as detailed in section 6 of this report) to be added to the 1 October meeting.
 - Update on the priorities of the Health and Wellbeing Board for 2015/16 to be added to the work programme.
 - An item regarding access to GP practices and the future supply of GPs be added to the work programme (as detailed at paragraph 4.2 below)

4. In-depth topic review selection

- 4.1. It was agreed at the last meeting held on 23 June 2015 that Members should forward any suggestions for an in-depth review topic to the Democratic Services Officer prior to 23 July 2015. At the last meeting it was suggested that consideration could be given to the possibility of Care in the Community being a potential in-depth review topic. However, it was agreed the Committee should firstly consider a report giving more detail about how care in the community is monitored and providing value for money. A report entitled "ensuring quality and value for money in adult social care" is included as item 11 on the agenda for this meeting.
- 4.2. A further suggestion was received regarding access to GP Services based on the CQC's comments in the pilot GP inspections and some of the previous issues considered by the committee relating to GP practices. This was discussed at the pre-agenda meeting and it was decided that this should instead be added as an item to the work programme for consideration at a future meeting of the committee and should consider issues around access to GP practices and the future supply of GPs.
- 4.3. At the pre-agenda meeting an additional suggestion was also made relating to how far Medway has gone in developing a dementia friendly community. It was agreed at the pre-agenda meeting that this should be recommended to the committee to be put forward as the in-depth review topic for consideration.
- 4.4. Attached as Appendix 2 to this report is the completed template illustrating how the potential topic for an in-depth review has been selected.
- 4.5. The Committee is asked to agree the dementia topic (as attached at Appendix 2) as the potential topic/s from this Committee to forward for consideration. In October, there will then be an informal discussion between all Overview and Scrutiny Chairmen, Vice-Chairmen and Opposition Spokespersons to consider the long list of topics put forward by each Committee which will then be considered by the Business Support Overview and Scrutiny Committee on 3 December 2015 where a programme of reviews for the period January to September 2016 will be agreed.
