ACUTE MENTAL HEALTH INPATIENT BED REVIEW UPDATE

Summary

The attached report sets out the response from Kent and Medway NHS and Social Care Partnership Trust (KMPT) in respect of the request for regular updates on the position with the acute mental health inpatient beds review.

1. Budget and Policy Framework

- 1.1 Under the Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council may review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. In carrying out health scrutiny a local authority must invite interested parties to comment and take account of any relevant information available to it, and in particular, relevant information provided to it by a local Healthwatch. The Council has delegated responsibility for discharging this function to this Committee and to the Children and Young People's Overview and Scrutiny Committee as set out in the Council's Constitution.
- 1.2 The terms of reference for the Health and Adult Social Care Overview and Scrutiny Committee (Chapter 4 Part 5 paragraph 22.2 (c) of the Constitution) includes powers to review and scrutinise matters relating to the health service in the area including NHS Scrutiny.

2. Background

- 2.1. Attached to this report is Appendix 1 a report from KMPT. Appendix 2 shows the out of area bed usage.
- 2.2. The following questions have been put to KMPT since the pre-agenda Meeting and these have been responded to in the attached report. These are as follows:

- the latest figures/details on acute inpatient beds out of area placements
- an update on the number section 136 agreements and the impact of losing the street triage scheme
- an update on the staffing of the Crisis Resolution Home Treatment Teams

3. Risk Management

3.1. There are no specific risk implications for Medway Council arising directly from this report.

4. Legal and Financial Implications

- 4.1. Under the Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council may review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. In carrying out health scrutiny a local authority must invite interested parties to comment and take account of any relevant information available to it, and in particular, relevant information provided to it by a local Healthwatch organisation. The Council has delegated responsibility for discharging this function to this Committee and to the Children and Young People's Overview and Scrutiny Committee as set out in the Council's Constitution. The Committee may make reports and recommendations to relevant NHS bodies and health service providers who can be required to respond formally within 28 days of a request for a response.
- 4.2. Recently published Department of Health guidance to support Local Authorities and their partners to deliver effective health scrutiny (published June 2014) emphasises the primary aim of health scrutiny is to strengthen the voice of local people, ensuring that their needs and experiences are considered as an integral part of the commissioning and delivery of health services and that those services are effective and safe.
- 4.3. The guidance states that local authorities will need to satisfy themselves that they keep open effective channels by which the public can communicate concerns about the quality of NHS and public health services to health scrutiny bodies. In the light of the Francis report local authorities are advised in the guidance to consider ways of independently verifying information provided by relevant NHS bodies and relevant health service providers for example, by seeking the views of local Healthwatch.


1. Introduction

- 1.1 This report focuses on four key areas. It provides the regular monthly update on younger adult bed usage including acute inpatient out of area placements. In addition and at the invitation of the Medway Council HASC Overview and Scrutiny Committee it provides an update on the number of section 136 assessments and the impact of the reduction in the Street Triage scheme and an update on the current staffing of the Crisis Resolution Home Treatment [CRHT] Teams. It also provides an update on the ongoing partnership working between KMPT and Medway Council to promote closer working with social workers.
- 1.2 The Committee is asked to note the content of the report.

2. Younger adult bed usage including acute inpatient out of area placements

- 2.1 The number of external bed days utilised in months 1 to 7 (April to October 2015) 2015/16 remains considerably higher than in the comparable period in 2014/15. During months 8 and 9 (November and December 2015) however the 2015/16 data drops to roughly the same level as 2014/15. The final three months (January to March 2015) of 2014/15 resulted in the highest use of external beds for the year, it remains to be seen if 2015/16 will follow the same pattern.
- 2.2 Delayed transfers of care [DToCs], those service users who no longer require acute inpatient care and are deemed fit for discharge from the KMPT bed and require other health or social interventions, continue to have a significant impact on the use of external beds.
- 2.3 The figure below provides the current use of external beds as compared with 2014/15. It also shows the number of DToCs, those service users who no longer require acute inpatient care and are waiting transfer to another health or social care setting.

Younger Adult Acute Bed Monitoring




2.4 KMPT remains focussed on reducing out of area bed usage. To support this twice weekly structured and detailed planning telephone calls continue to take place with representatives from the Clinical Commissioning Group [CCG], social care and KMPT's acute and community recovery service lines. These calls review all DToC service users and identify where blockages in the system are. The outputs include agreed and detailed actions, with an identified lead, to resolve blockages and agreed and detailed discharge plans to help

move these service users on to an environment more suitable to meet their needs thereby ensuring all service users receive the right treatment at the right time and in the right place.

2.5 Appendix 2 provides the detailed bed usage data for November / December 2015.

3. Section 136 assessments and the impact of reducing the Street Triage scheme

3.1 In the twelve month period January 2015 to December 2015 a total of 326 section 136 assessments were undertaken for people presenting from the Medway Consortia locality. This represents 35% of all section 136 assessments undertaken Trust-wide in period. The table below provides a summary of these presentations by month.



3.2 Of these 37 (11%) resulted in an admission under section, 31 (10%) resulted in an informal admission and 258 (79%) were not admitted. The table below provides a summary of the outcome of these presentations.

- 3.3 In terms of the reduction in the Street Triage initiative the Trust is unable to specify any direct impact as a result of this at this time, although anecdotally admissions have been avoided.
- 3.4 The current Street Triage Service provided to the Medway locality operates Thursday to Saturday 18.00 and 02.00 hours and is part of the pan-county service based at the Kent Police control room. Discussions with South East Coast NHS Ambulance Foundation Trust [SECAmb] to operate a similar service from their Emergency Operations Centre are expected to conclude in mid January 2016.
- 3.5 A day service has been established at Northfleet Police Station in conjunction with the Trust's Criminal Justice Liaison and Diversion Service. To date this service has only been open to those representing within the Northfleet Police Station catchment area. From 18 January 2016 the service is extending to Medway and Swale and will be responding to the Police and SECAmb. This recognises patients tend to present in crisis both inside and outside the area they live in.

4. Current staffing of the Crisis Resolution Home Treatment [CRHT] Teams

4.1 The table below provides a summary of the current staffing within the Medway CRHT. The staffing model adopted follows a therapeutic staffing model.

4.2 The Trust is actively seeking to address vacancies through an ongoing recruitment process which includes a rolling programme for advertisement and interview. In addition and to ensure consistency and continuity the Trust is considering introducing short term contracts for NHS Professionals [NHSP] and / or agency staff whilst recruitment is underway. The Acute Service Line is also considering internal rotation with inpatient services and skill mix to help mitigate the current shortage.

5. Closer Working (Social Workers)

- 5.1 On Tuesday 1 December 2015 the first in a series of meetings and workshops took place between KMPT and Medway Council to look at how best to promote closer working. This first meeting focused on developing a plan to take this work forward. Agreement was reached to convene a series of workshops to gain a comprehensive understanding of any issues and agree joint solutions.
- 5.2 The first workshop, date to be confirmed, will focus on understanding what each organisation does. It will look at common points and identify how both organisations can be more effective and efficient for the benefit of the service user. Subject to discussion and agreement a potential outcome of this workshop will be to establish regular forums in which both organisations are represented and in which complex cases can be discussed and next steps agreed. This will also provide opportunity to monitor actions and resolve any blockages to progress as they occur.

6. Conclusion and Recommendation

- 6.1 The Medway HASC Overview and Scrutiny Committee is requested to note the content of this report.
- 6.2 The Medway HASC Overview and Scrutiny Committee is requested to support the ongoing work as outlined above with a recommendation that a report on progress be submitted to the Medway HASC Overview and Scrutiny Committee at its first meeting in the new municipal year.

- The current bed capacity for KMPT is 166 this is the position at the end of the month, although actual beds available can vary on a daily basis. The data submitted to the HASC reports a snapshot of beds occupied (as at midnight each day). Reasons for beds showing as available on the HASC report, when they can in fact not be used, include (see appendix 1):
- Maintenance of bed stock e.g. a room has been damaged and needs to be fixed
- Managerially led decisions based on specific circumstances e.g. management of infection control, such as a D&V outbreak
- Time gap in the data set between the discharge of one service user and the admission of another i.e. a bed may be vacant for a short time frame over midnight, whilst one service user is discharged and another takes up occupancy.
- Service users on leave / AWOL

In addition, KMPT has a rolling programme of maintenance to upgrade current accommodation, this is to improve the overall quality and patient experience of inpatient facilities, and may have an impact on the actual beds available daily.

- KMPT has a plan to increase total bed availability to 174 beds, with a 95% optimal operating capacity of 165 (to ensure safety and quality standards meet national guidance). This target should be reached in 2016/17.
- KMPT will always use local beds wherever possible, and when appropriate to individual need. On occasions an external bed placement may be required despite a KMPT bed being available, this decision will be based on how the clinical needs of the patient are best met and a longer term view of the most effective use of beds.
- Graph 1 demonstrates that bed usage is volitile. The mean external bed usage is below the target bed capacity of 174.
- Analysis of service users with frequent attendances in the urgent care setting has been used to drive individual case discussions with senior clinicians and care coordinators these have been able to inform and improve individual care planning and crisis management.
- There are minimal known data quality issues and where identified, these are flagged to the relevant service manager to ensure prompt resolution e.g. where a closed bed hasn't been updated on RiO.




