REVIEW OF POLLING DISTRICTS AND POLLING PLACES

Summary

This report recommends changes to the configuration and designation of polling districts and polling places in the light of issues arising since the combined Local, Parish and General elections in May 2015 and updates them on the allocation of polling stations by the Returning Officer.

1. Budget and Policy Framework

1.1 The duty to divide Medway into polling districts is a matter that cannot be determined by Cabinet under the Local Authorities (Functions and Responsibilities) (England) Relegations 2000 (as amended). Therefore, this is a matter for Council.

2. Background

- 2.1 Under the Representation of the People Act 1983, the Council has a duty to divide Medway into polling districts and to designate a polling place for each district for UK Parliamentary elections. It also has to keep these arrangements under review. It is good practice to undertake the same exercise for local government elections and in doing so, every effort must be made to ensure that the polling district scheme mirrors as closely as possible that agreed for Parliamentary elections.
- 2.2 When designating polling districts:
 - (a) the Council must seek to ensure that all the electors in the Constituency have such reasonable facilities for voting as are practicable in the circumstances;
 - (b) each Parish must be in a separate polling district unless there are special circumstances that lead the Council to determine otherwise;

- (c) the Council must designate a polling place for every polling district, unless the size or other circumstances of the polling district are such that the situation of the polling stations does not materially affect the convenience of the electorate;
- (d) the Council must seek to ensure that so far as is reasonable and practicable, the polling places they are responsible for are accessible to all electors, including those who are disabled, and when considering the designation of a polling place, must have regard to the accessibility needs of disabled persons;
- (e) the polling place for a polling district must be within the area of the district unless special circumstances make it desirable to designate an area either wholly or partly outside of the polling district
- 2.3 A Polling Station is the actual area where the process of voting takes place, and must be located within the polling place designated for the particular polling district. This function is the responsibility of the Returning Officer.
- 2.4 Section 16 of the Electoral Administration Act 2006 introduced a number of changes to the Representation of the People Act 1983 in respect of the way in which reviews of polling districts and polling places must be undertaken. The most significant of these is that the Council must undertake a review every 4 years at a minimum. The Electoral Registration and Administration Act 2013 introduced the timing of compulsory reviews of Parliamentary polling districts and polling places. Subsequent compulsory reviews must be started and completed within the period of 16 months that starts on 1 October of every fifth year after 1 October 2013. Practice at Medway has been to conduct a review after each election in any case.
- 2.5 The last review was reported to Council on 22 January 2015. At that time, approval was given to a scheme of Polling Districts and Polling Places and this report seeks approval to amendments to that scheme in the light of comments arising from the combined Local, Parish and General elections in May 2015. An informal working group of Members has been established and their proposals, along with the comments of the Returning Officer are included on the individual Ward sheets set out in Appendix 1 to the report. The Working Group comprises Councillors Brown-Reckless, Fearn, Griffiths, Maple, Opara, Potter and Wildey.

3. The review and consultation

3.1 The informal working group represented all the political Groups on the Council and the views of the Ward Member and Parish Council affected, on the proposal were provided. Group Leaders were also consulted on the proposed changes. In accordance with the requirement to publish a notice of the review of polling districts/places, the proposals were posted on the Council's website in February 2016. In general, the proposals are to implement arrangements to resolve comments arising from and since the elections held in 2015, specifically relating to the polling station for polling district RCH2 in Cuxton and Halling ward. The change to polling place was proposed after a site visit was undertaken by staff in electoral services who took into account a range of issues, including disabled access.

Cuxton and Halling Ward

- 3.2 In light of an increased electorate due to the St Andrew's Park Development in RCH2 the Group recommended, and the Council agreed in January 2013 to allocate polling district RCH1 as the polling place for RCH2 and allocate all the electors to vote at the Scout Hut on Bush Road. The views and comments of Councillor Maisey as (the then) Ward Councillor supported that approach at the time. In the light of the likely increased importance of the allocation of the polling station for RCH2 in 2015 when all parish Council seats were up for election, the Working Party recommended, and Council approved the continued allocation of polling district RCH1 as the polling place for RCH2 and allocation of all the electors to vote at the Scout Hut on Bush Road. However, in the light of increased issues regarding parking at the Scout Hut, Council asked officers to investigate, as a longer-term option, the feasibility of a working men's club at the Halling roundabout as a suitable alternative and asked them to report back to the Working Party and in due course to the Council.
- 3.3 Having undertaken a site visit and confirmed the support of the Ward Councillor and Halling Parish Council, the Working Party are recommending that New Town Social Club at 50 Formby Road be the polling station for electors in polling district RCH2 and that the scheme of polling districts and polling places be amended to show the polling place for polling district RCH2 to be RCH3 where the Social Club is located. The Returning Officer has indicated that he is likely to concur with the recommendation.

Strood North ward

3.4 When Council considered the last report on this matter, they asked officers to report back on the poling arrangements in Strood North, having been made aware of issues regarding polling stations at Temple Mill Primary School and Abbey Court School. However, the Returning Officer has been able to confirm the continued use of the car parking space on the site of Temple Mill Junior School/Children's Centre for the Portakabin and of Abbey Court school for the PCC elections on 5 May. Therefore a review of the polling arrangements has not been required this year. The situation will be kept under review and further work undertaken when necessary.

Conclusions

- 3.5 Appendix 1 shows the proposed Scheme of polling districts and polling places for the whole of Medway, with the proposed amendment in Cuxton and Halling ward.
- 3.6 Rather than designate specific buildings as Polling Places, it is recommended that each Polling District continue to be designated as the Polling Place for the district. This avoids having to seek Council approval each and every time a building becomes unavailable, particularly in the run-up to an election. The Returning Officer has given an undertaking that he will consult with the Informal Working Group if it becomes necessary to change any polling stations after the scheme has been agreed.
- 3.7 A Diversity Impact Assessment has been undertaken on the proposals, as set out in Appendix 3 to the report.

4. Financial implications

4.1 The costs of Parliamentary elections (General and European), Police and Crime Commissioner elections and national Referendums are recharged to the Government. The Council meets the costs of local and Parish elections. In terms of costs of premises, schools and other public buildings, only costs for the additional heating, lighting and caretaking costs can be charged; other private premises are subject to a hire cost which varies considerably. The total average cost of polling stations for a full election is in the order of £14,000 depending if they all submit invoices. The proposals in this report would not increase the costs.

5. Legal implications

5.1 In accordance with Schedule A1 to the Representation of the People Act 1983, the Council must publish a notice of the holding of the review and must consult with the Returning Officer and publish his comments on the review. Any elector within any constituency located wholly or in part within Medway may make representation regarding the review. On completion of the review the Council must give reasons for its decisions in the review and must publish the information set out in the Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006.

6. Risk management

6.1 Risk management is an integral part of good governance. The Council has a responsibility to identify and manage threats and risks to achieve its strategic objectives and enhance the value of services it provides to the community. The following table shows any significant risks arising from the matters in this report.

7. Recommendations

Council is recommended to:

- 7.1 Approve the scheme of Polling Districts and Polling Places as set out in Appendix 1, including the designation of a Polling District as the Polling Place in respect of Parliamentary elections and to designate the Parliamentary Polling Districts and Polling Places as the Polling Districts and Polling Places for Local Government elections.
- 7.2 Authorise the Chief Executive to designate an adjoining Polling District as the Polling Place where no suitable polling station is available within the original Polling Place.

7.3 Note the designation of polling stations recommended by the Returning Officer as set out in Appendix 2 to the report.
