MEDWAY CLINICAL COMMISSIONING GROUP – KENT AND MEDWAY SUSTAINABILITY AND TRANSFORMATION PLAN UPDATE

Summary

This report provides an update on the current development of the Kent and Medway Sustainability and Transformation Plan.

Following a meeting on the 3 March, between the CCG and Councillors, a number of changes were communicated to the author of the Initiation Document.

It was agreed how the issues and priorities which are important for Medway are articulated in the STP discussions and associated documentation.

The local Medway and Swale STP Strategy group reviewed the latest version of the Kent and Medway Sustainability and Transformation Plan at a meeting on the 29 March 2016. A number of revisions were identified and agreed by the group.

These revisions were presented in a letter (Appendix 2) sent, by Caroline Selkirk, Chair of the local Medway and Swale STP Strategy group, on the 31 March 2016 to the Senior Responsible Officer for the Kent and Medway Sustainability and Transformation Plan.

A further meeting was held on Tuesday 5 April where a small number of further points were agreed and a letter covering these was submitted to the SRO on 14 April 2016 (Appendix 3).

The Kent and Medway Sustainability and Transformation Plan was tabled as an Agenda Item at the CCG Accountable Officers meeting held on the 8 April 2016.

Attached at Appendix 1 is the latest checkpoint STP submission.

1. Budget and Policy Framework

1.1 This report is for information only

2. Background

2.1 The NHS Five Year Forward View sets out a vision for the future of the NHS. It was developed by the partner organisations that deliver and oversee health and care services including:

- NHS England (NHSE)
- NHS Improvement (Monitor and the NHS Trust Development Authority)
- Health Education England (HEE)
- The National Institute for Health and Care Excellence (NICE)
- Public Health England (PHE)
- Care Quality Commission (CQC)

2.2 The six national NHS bodies have set a clear list of national priorities for 2016/17. Clinical Commissioning Groups are required to produce two connected plans:

- A five year Sustainability and Transformation Plan (STP), place based and driving the Five Year Forward View; and
- A one year Operational Plan for 2016/17, organisation-based but consistent with the emerging STP.

3. Risk management

3.1 Risk assessments, with mitigating actions, will be undertaken once the STP has been approved by NHS England in April 2016.

4. Consultation

4.1 Regular meetings have been established with local health providers and Medway Council to collaboratively deliver the STP.

5. Financial implications

5.1 The Financial Implications of the STP will be progressed through the relevant governance arrangements when this information becomes available.

6. Legal implications

6.1 The Health and Wellbeing Board has a statutory obligation under section 195 Health and Social Care Act 2012 to encourage persons who arrange for the provision of any health or social care services, to work in an integrated manner for the purpose of advancing the health and wellbeing of the people

in Medway. Supporting the development of a Sustainability and Transformation Plan is therefore within the remit of the Health and Wellbeing Board. However should there be a requirement within the Plan for any commitment to the use of Council resources or action by the Medway Council, decisions to that effect would need to be taken by either the Council, the Leader and Cabinet or the relevant Director (under delegated authority).
