Summary

2.1.1 Report title Attendance of the Leader of the Council

Outcome:

The Committee agreed to:

- a) note the report and;
- b) note the commitment from the Leader to look into the issue about the ownership of sure start centre properties.

2.1.2 Report title Attendance of the Portfolio Holder for Resources

Outcome:

The Committee agreed to:

- a) thank the Portfolio Holder for Resources for his attendance, and
- ask for a report back to the Committee on the outcome of investigations into the funding opportunities for extending the use of solar panels on Council buildings.

2.1.3 Report title Member's Item – Medway Norse

Outcome:

The Committee agreed to:

- a) note the report, and
- b) note the offer for further discussions to take place on the future of the café at the Adult Education Centre in Rochester.

2.1.4 Report title 6 Monthly Review of the Council's Corporate Business Risk Register

Outcome:

The Committee agreed to:

- a) note the Extended Management Team's recommendations on amendments to the Council's Risk Register as detailed in section 3 of the report and Appendices A and B, and
- b) recommend the revised Risk Register for final approval by Cabinet on 10 May 2016.

Cabinet Decision

78/2016 The Cabinet approved the amendments to the Council's Risk Register, as detailed in Appendix A and B to this report.

2.1.5 Report title Housing (Demand, Supply and Affordability) Task Group

Outcome:

The Committee agreed to:

- a) note the comments from the Regeneration, Community and Culture
 O&S Committee on the report from the Task Group;
- b) approve the report from the Task Group and refer it for consideration to Cabinet on 10 May and also, in respect of recommendations 3 and 9, the Director of Regeneration, Culture, Environment and Transformation:
- c) refer the report to the Health and Well Being Board and ask that it be circulated to all Councillors following the Cabinet meeting on 10 May;
- d) ask that the report be formally considered as part of the process for developing the new Local Plan;
- e) re-order the recommendations in the Task Group's report as follows:
 - o Move recommendation no 13 to be the first recommendation
 - Move recommendation no 8 to no 4.

Cabinet Decision

66/2016

Recognising that the Council, as a regeneration authority, will wish to continue to use its best endeavours to meet its objectively assessed housing needs, the Cabinet agreed to make representations to the Government that the Council should not be penalised as a result of developers failing to deliver housing, particularly where planning permission has been granted.

67/2016

Given the importance of building enough homes to meet the increasing need for housing, the Cabinet agreed to lobby the Government to introduce measures to encourage developers and land owners to develop sites for housing which have the benefit of planning permission or are allocated for housing development, within the relevant timeframe, in the Developmen Plan or Neighbourhood Plan.

68/2016

In relation to sites identified in recommendation 2 above, Cabinet agreed to ask the Government to consider introducing a national scheme for a local tax on undeveloped (land banked) land in order to:

- incentivise developers and/or landowners not to sit on sites they have acquired and have either planning permission or are allocated for housing development, within the relevant timeframe, in the Development Plan or Neighbourhood Plan, and;
- to build out more quickly where planning permission has been given.

69/2016

The Cabinet agreed with its partners to explore the use of more innovative construction methods and forms of housing in order to increase the supply of homes.

The Cabinet noted that the Director of Director of Regeneration Culture, Environment and Transformation is asked to agree tha developers be offered at the pre-application stage, as a matter of course, the opportunity to commission services needed before development on sites can commence, for instance archaeology, ecology and contamination studies in order to allow schemes to start on site without further delay.

70/2016

The Cabinet agreed to work with partners to identify suitable funding sources and opportunities in order to develop additiona homes, including securing external funding to help meet the costs involved in getting sites ready for development.

71/2016

The Cabinet agreed to ask Council officers to identify opportunities to improve working relationships with developers (including sub contractors) in order to improve the supply of skilled labour to the industry and, further, to identify achievable targets to help alleviate the shortages in the industry, including working with local education, skills and training providers, such as the Medway University Technical College and Mid Kent College.

72/2016 The Cabinet agreed to review the scope to extend the use of home bonds to help tenants find alternative accommodation and work with the private rented sector to encourage landlords to let properties to residents in housing need and to those in receipt of Housing Benefit.

73/2016 In order to free up much needed social housing, the Cabinet agreed to review, in relation to its housing stock, the incentives that are available to residents aimed at encouraging them to move into more suitable forms of affordable housing.

> The Cabinet noted that the Director of Regeneration, Culture, Environment and Transformation is asked to continue to promote shared ownership products and similar available products that will support home ownership in Medway.

74/2016 Given that 50% of supply is now concentrated in the eight largest private housebuilders, The Cabinet agreed, with the aim of helping increase the supply and type of housing available, to:

- a) identify and assist with overcoming the barriers for small and medium-sized enterprises (SME) builders entering the market in Medway and
- b) consider what the Council can do to encourage SME builders to enter and remain in the market in Medway.

75/2016 The Cabinet agreed to ensure that there are appropriate resources in place to ensure that tenants in the private rented sector have sufficient protection with regard to minimum standards of accommodation, repair and good management.

76/2016 Subject to this being financially viable, the Cabinet agreed to consider the potential of options to generate extra finance, for example prudentially borrowing and use the funds to build and operate housing across all tenures either by working in partnership with a local housing provider or by alternative means.

2.1.6 Report title Review of the Council's Constitution - Proposed revisions to the Overview and Scrutiny Rules

Outcome:

The Committee agreed to:

- a) note the proposed revisions to Article 6 and the Chapter on Overview and Scrutiny Rules attached at Appendix A and forward these to full Council on 28 April for approval with other revisions to the Constitution.
- b) note that proposed changes to the Terms of Reference of the Joint Kent and Medway Health Overview and Scrutiny will be subject to approval by Kent County Council (KCC) as well and that Full Council will be asked to authorise the Monitoring Officer to finalise the wording in consultation with KCC and the Chairman and Opposition Spokespersons of the Council's Health and Adult Social Care Overview and Scrutiny Committee.

Full Council Decision

- (a) The Council agreed that Rule 16.2 of the Council Rules be suspended, to enable the proposed minor revisions to the Council Rules to be agreed at this meeting of the Council.
- (b) The Council approved the proposed revisions to the Constitution as set out as tracked changes in Appendix B to the report.
