Summary

This report advises Members of the current work programme for discussion in the light of latest priorities, issues and circumstances, giving Members the opportunity to shape and direct the Committee's activities.

1. Budget and Policy Framework

1.1 Under Chapter 4 – Rules, Part 4 paragraph 21.1 (xv) General Terms of Reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the existing work programme for the Committee.

3. Agenda planning meeting

Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. An agenda planning meeting was held on 4 August 2016 at which Members discussed and agreed the following in relation to the Committee's forthcoming programme of work.

3.1 **General Practice update**

The Committee previously asked for an update on GP services with particular reference to waiting times for GP appointments and the future of the GP practice at Canterbury Street. Since the last meeting of the Committee the Head of Primary Care for NHS England South (South East) and the Accountable Officer for the NHS Medway Clinical Commissioning Group have provided a detailed briefing note ahead of the planned move of the Medway NHS Healthcare Centre from Canterbury Street in Gillingham to Balmoral Gardens. This was circulated to all Members of the Committee and relevant

ward members. The move was planned to take place on the weekend of 20-21 August.

It was agreed at the agenda planning meeting that NHS England South (South East) and NHS Medway CCG should be invited to provide a report to the Committee in October on the General Practice Forward View published by NHS England in April 2016 which sets out national commitments to stabilise and transform general practice, improving services for patients and investing in new ways of providing general practice services. This is a five year programme of work with specific, practical and funded steps – on investment, workforce, workload, infrastructure and care re-design. Members have asked if the presentation could cover the likely impact and timescales for change in Medway.

3.2 Medway Foundation Trust (Medway Maritime Hospital)

Following the agenda planning meeting the Chief Executive of Medway Foundation Trust has been invited to the October meeting of the Committee to provide a progress report which will cover several of the issues raised by the Committee at its meeting on 21 June including details of how the Medical Model works, review of lifestyle services and food menus plus the percentage of staff who are EU (non British) nationals.

4. Kent and Medway Joint Health Overview and Scrutiny Committee Meeting - 4 August

The Joint Kent and Medway Health Overview and Scrutiny Committee met on 4 August to review progress on two major service reconfigurations; the Kent and Medway Hyper Acute and Acute Stroke Services Review and the Kent and Medway Specialist Vascular Services Review. A further meeting of the Joint Committee will take place in November following further public and stakeholder engagement on the emerging options. Next steps for both reviews will need to be aligned with the Sustainability and Transformation Plan process. The comments of the Joint Committee will be taken into account as both reviews progress. The agendas and minutes of the Joint Committee meetings are published on the Council's website.

5. South East Coast Ambulance Service NHS Foundation Trust (SECAmb)

The Acting Chief Executive of SECAmb has been invited to attend the October meeting of the Committee. SECAmb last attended the Committee in March 2016. Since then the Trust has been issued with a warning notice by the Care Quality Commission (CQC), following a comprehensive inspection in May. The CQC has called on the Trust to make significant improvements to a number of systems and processes which are not operating effectively as well as adequately managing NHS111 calls in a timely manner.

The Trust now has until September to address the immediate concerns highlighted by the CQC before a full report will be published later in the year. The Trust has stated that efforts to address the issues highlighted by the CQC are already underway with an action plan developed which will be tracked by the Trust's Executive Team and Board. Actions include:

- Improve operational performance including increasing the number of staff deployed to provide patient care.
- Implement a new asset register for clinical equipment.
- Ensure medicines practice are understood and operated appropriately by staff.
- Look to establish a new patient safety and quality director role to bring together all aspects of patient safety, safeguarding and patient experience to ensure joined patient safety reporting mechanisms and clear identification and communication of learning.
- Increase staff recruitment in NHS 111 with the aim of performing against a new improvement trajectory agreed with service commissioners.

SECAmb have been asked to cover the recent CQC Inspection findings and the Trust's response/action plan in it's report to the October meeting of the Committee and in addition an update on the following issues reviewed by the Committee in March:

- Re-triage process
- Performance update on 999 and NHS 111
- Public Access Defibrillators

The Committee also expressed an interest in a visit to the NHS 111 control centre in Ashford and it is hoped this can be arranged for late October or early November after the Committee has had an update on performance.

6. Task Group on How far has Medway gone in developing a Dementia Friendly Community?

The first meeting of the Task Group should take place at the end of August or in early September. Work is underway at officer level to complete an initial stock-take across arrange of Council functions to assist the Task Group in determining the scope and key lines of enquiry for the review. In addition invitations have been extended to the Dementia Policy Team at the Department of Health and to representatives of the Alzheimer's Society nationally and locally to provide evidence at an early point in the review process. In the meantime all Members of the Task Group (Councillors Wildey, Purdy, Griffin, Shaw and Freshwater) have been encouraged to attend a Dementia Friends session, if they have not already done so. It is possible that this Task Group will generate recommendations cutting across the terms of reference of three of the Council's Overview and Scrutiny Committees. The membership of the Task Group will reflect this with Councillors drawn from this Committee, the Regeneration, Community and Environment Overview and Scrutiny Committee and the Business Support Overview and Scrutiny Committee.

7. South East Regional Health Overview and Scrutiny (HOSC) Network

The Chairman of the Committee attended the regional network meeting on 14 July 2016. The network includes the Chairmen and health scrutiny officers from Medway, Kent, East Sussex, West Sussex, Surrey and Brighton and Hove. Representatives from the Centre for Public Scrutiny, NHS England – South (South East) and the Care Quality Commission were in attendance. NHS England provided an update on Specialised Commissioning, Community

Pharmacies, Patient Transport Services and GP Commissioning. There was also a presentation on Sustainability and Transformation Plans and an update from the CQC.

8. Forward Plan

- 8.1 The latest Forward Plan of forthcoming Cabinet decisions was published on 8 August 2016.

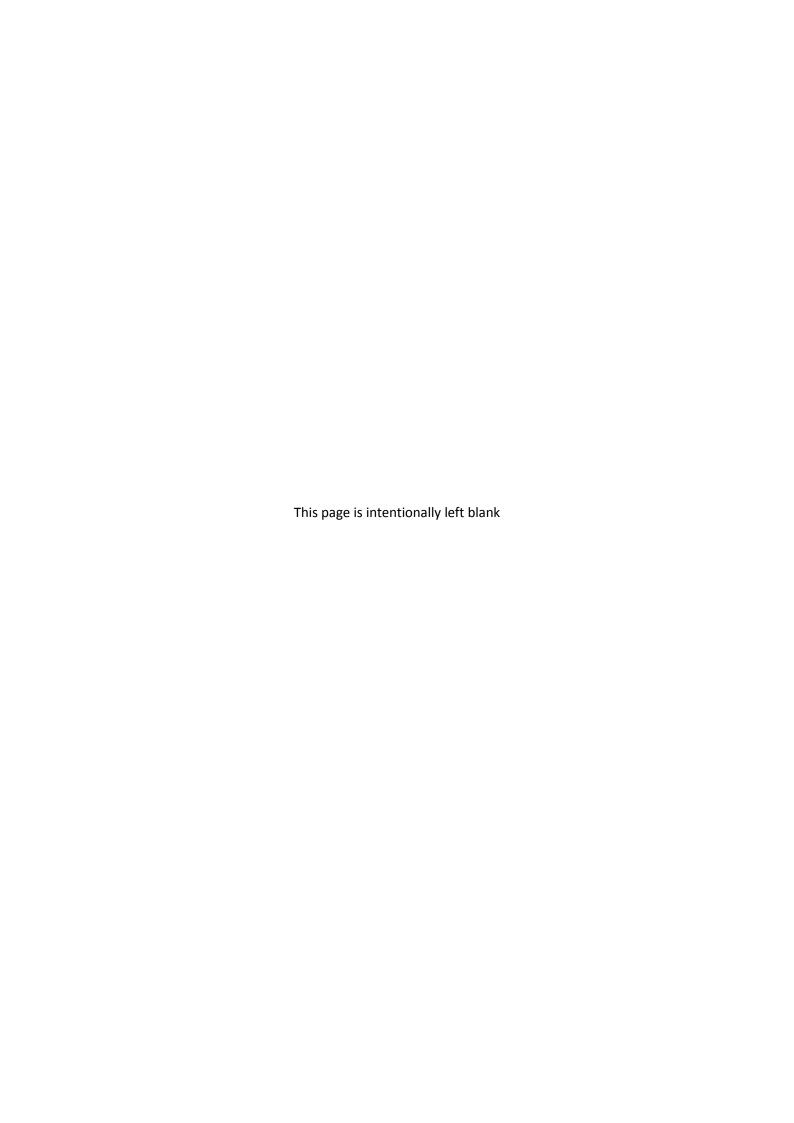
