The proposal removes the right for a member of staff to appeal against a decision to extend their period of probation.

The current position allows for the right of appeal but this is considered unnecessary as any extension provides an opportunity for the member of staff to reach the required performance standards, and the alternative to an extension of a probationary period would be to proceed to a formal probationary review hearing where one of the outcomes available to the hearing panel would be to terminate the employees contract.
