Summary

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives members the opportunity to shape and direct the Committee's activities over the year. Members are also asked to note the process for selection of topics for the next round of Scrutiny Task Groups in 2018/19 and all Members of the Committee are invited to submit ideas based on the criteria set out in paragraph 7.2.

1. Budget and Policy Framework

1.1 Under Chapter 4, Part 5 of the Constitution – Overview and Scrutiny Rules, paragraph 21.1 (xv) General terms of reference, each Overview and Scrutiny Committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 11 May 2017.
- 3.2 At the meeting it was confirmed that a call-in request had been received in relation to a decision made at Cabinet on 9 May 2017 regarding Transformation of Early Help Services. This had therefore been added to the agenda for 30 May 2017.
- 3.3 At the meeting it was also agreed to add items on 'Children's Social Care Complaints and Compliments Annual Report' and 'Transformation of Early Help Services Outcomes of Consultation' to the 1 August 2017 meeting.

4. Cabinet Forward Plan

5. Teacher and Parent Governor representative vacancies on the Committee


- 5.1 Invitations for expressions of interest in the Parent Governor representative positions and the teacher position on the Committee were sent out earlier in the year and the closing date for both was 10 March 2017.
- 5.2 In relation to the two Parent Governor representative vacancies, no expressions of interest were received. Further invitations will be sent out in September 2017.
- 5.3 An expression of interest was received for the teacher position from Fay Cordingley, Deputy Headteacher at St Margaret's Junior School, Rainham. Fay has been teaching in the Medway area for 16 years and considers her experience in all aspects of teaching and collaborative mentoring to be of benefit to this role on the Committee.
- 5.4 It is therefore requested that the Committee consider this expression of interest and recommend the appointment of Fay Cordingley to the Teacher position of the Children and Young People Overview and Scrutiny Committee for a two year term.

6. Scrutiny Task Group – Employment Opportunities for 18-21 Year Olds (including apprenticeships)

6.1 Membership of the Employment Opportunities Task Group was confirmed at Annual Council on 17 May 2017. At the pre-agenda meeting on 11 May 2017, it was agreed that the initial scoping meeting for the Task Group will take place in mid-late June 2017.

- 7. Selection of scrutiny topics for the next round of scrutiny reviews
- 7.1 Since 2011 Medway Council's Overview and Scrutiny Committees have operated a systematic and criteria-based approach to the selection of topics for Scrutiny Task Groups.
- 7.2 This reflects national best practice and is summarised below:

Questions to ask when prioritising topics for review



7.3 As agreed by Full Council, up to three Scrutiny Task Groups can be supported in each twelve month period. The selection of topics for the current round of indepth scrutiny reviews was agreed by the Business Support Overview and Scrutiny Committee on 3 December 2015 as follows:

Business Support Overview and Scrutiny Committee	Housing in Medway – demand, supply and affordability – carried forward from previous round of reviews
Health and Adult Social Care Overview and Scrutiny Committee	How far has Medway gone in developing a Dementia Friendly Community
Children and Young People and Regeneration, Culture and Environment Overview and Scrutiny Committees	Employment Opportunities for 18 to 21 year olds (including apprenticeships)

- 7.4 The Task Group on Employment Opportunities will start in June and report its findings and recommendations to Cabinet in December 2017. It is proposed to now commence the established process for the selection of further topics for the next round of Scrutiny Task Groups in 2018/19. The timetable for this would be as follows:
 - May early July: Each Overview and Scrutiny Committee to be notified of the proposed timetable and process for the determination of the next round of in-depth reviews and Members invited to submit suggestions for topics taking into account the criteria adopted for the selection of reviews (as set out above);
 - July- August: Overview and Scrutiny Committee Chairmen, Vice
 Chairmen and Opposition Spokespersons use their pre-agenda meetings
 with officers to propose topics to be put forward and then each Overview
 and Scrutiny Committee will consider and agree topics to be put forward for
 prioritisation by the Business Support Overview and Scrutiny Committee
 exercising its co-ordinating role;
 - Late October: All Overview and Scrutiny Chairmen, Vice-Chairmen and Opposition Spokespersons meet informally to prioritise three of the topics put forward by Overview and Scrutiny Committees;
 - **30 November:** The Business Support Overview and Scrutiny Committee considers and agrees a programme of three in-depth reviews for the period January 2018 to February 2019 (recognising that one review may be delayed if it would not be possible for it to conclude and report its findings to the Cabinet before the local elections in 2019).

8. Implications for Looked After Children

8.1 Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent you should be a champion for looked after children and have the same high expectations of them as you would for your child, grandchild or niece/ nephew.

9. Financial and legal implications

- 9.1 There are no financial implications arising from this report.
- 9.2 Under The Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council has the power to review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. This Committee has the remit to review and scrutinise health services for children and must invite interested parties to comment on particular matters under review or scrutiny and take into account relevant available information and in particular, relevant information provided by Healthwatch Medway. The Committee may make reports and recommendations to relevant NHS bodies or health service providers.

These organisations are also under a statutory obligation to consult the Committee on any proposal for a substantial development or variation of children's health services in Medway.

9.3 The Parent Governor (England) Regulations 2001 provide for the arrangements relating to the election of voting parent governor representatives to education Overview and Scrutiny Committees.

10. Recommendations

- 10.1 That the Committee agree the work programme as set out at Appendix 1 subject to the following additional items for the meeting on 1 August 2017:
 - Children's Social Care Complaints and Compliments Annual Report
 - Transformation of Early Help Services Outcome of Consultation
- 10.2 That the Committee recommend Fay Cordingley be appointed to the Teacher position on the Committee.
- 10.3 To note the process for selection of topics for the next round of Scrutiny Task Groups in 2018/19 and invite all Members of the Committee to submit ideas based on the criteria set out in paragraph 7.2 above to the Democratic Services Officer ahead of the next agenda planning meeting for this Committee.
