Summary

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 18 September 2017.
- 3.2 Members noted that Cabinet, at their meeting on 21 November, will be discussing progress on developing a Regional Adoption Agency. It was felt that, rather than this being added to the agenda for this meeting, an update should be provided for Members by way of a briefing paper.
- 3.3 At the 1 August 2017 meeting of the Committee, Members added to the work programme (on a date to be determined) an update on Cookham Wood Young Offenders Institute Update. It is recommended that this be considered by the Committee in June 2018, with a focus on safeguarding responsibilities.
