## **Summary**

## 1.0 Budget and Policy Framework

1.1 Under Chapter 4 – Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

## 2.0 Background

2.1 Appendix 1 to this report sets out the existing work programme for this Committee. One of the Committee's' functions is to provide guidance and leadership on the development and co-ordination of the scrutiny function for all Overview and Scrutiny Committees. Appendix 2 sets out the work programmes for the other Overview and Scrutiny Committees.

## 3.0 Agenda Planning Meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information Members wish them to provide when scrutinising an issue.
- 3.2 An agenda planning meeting was held on 30 October. The Chairmen, Vice-Chairman and the Opposition Spokespersons were in attendance and were updated on the Committee's current work programme and advised of the reports to be submitted to this meeting. It was agreed that further consideration be given to the most appropriate meeting for the Committee to consider the information item on the outcome of the Corporate Peer Challenge

- of the Council, currently on the work programme under 'Date to be determined'.
- 3.3 Work is also underway to map arrangements for the scrutiny of alternative models of service delivery across Overview and Scrutiny Committees. It is envisaged that this Committee will scrutinise the overall performance of Medway Commercial Group and Medway Norse with scrutiny of the operational functions the responsibility of the relevant Overview and Scrutiny Committee. Further work needs to be done on the format of the ongoing scrutiny of the new Housing Company.
