MEDWAY NHS FOUNDATION TRUST (MFT) UPDATE

Summary

The report provides an update on the Improvement Plan developed by MFT in response to the findings of the Care Quality Commission (CQC) inspection of the Trust undertaken in November/December 2016. The report also provides updates on patient flows, Emergency Department and winter resilience, the workforce and Trust finances.

1. Budget and Policy Framework

1.1 Under the Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 the Council may review and scrutinise any matter relating to the planning, provision and operation of the health service in Medway. In carrying out health scrutiny a local authority must invite interested parties to comment and take account of any relevant information available to it, and in particular, relevant information provided to it by a local Healthwatch. The Council has delegated responsibility for discharging this function to this Committee and to the Children and Young People's Overview and Scrutiny Committee as set out in the Council's Constitution.

2. Background

- 2.1 At the March 2017 meeting, the Chief Executive and the Director of Communications of Medway Foundation Trust provided the Committee with a brief update on the findings of the Care Quality Commission (CQC) inspection findings that had been due to be published the next day.
- 2.2 MFT had received a rating of 'requires improvement', compared to the previous rating of 'inadequate' and would, as a result of this improvement, be exiting special measures.
- 2.3 The Committee was advised that the inspection had acknowledged major improvements at the Trust including sustained improvement in mortality rates and improved care in the emergency department. Areas highlighted as outstanding had included women and children's services and research. The hospital was also proud of achievements made with regard to its fractured hip

pathway. The inspection had identified 16 'must dos' for the hospital to address, which was a significant improvement on the 46 identified in August 2016. It was recognised that the hospital still faced challenges, particularly in relation to workforce, emergency department waiting times, access to elective surgery and cancer treatment.

2.4 The update provided by MFT is attached as Appendix 1. This provides a progress update on work undertaken since MFT last attended the Committee in August 2017.
