Summary

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives Members the opportunity to shape and direct the Committee's activities over the year.

1. Budget and Policy Framework

1.1 Under Chapter 4, Part 5 of the Constitution – Overview and Scrutiny Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny Committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 17 May 2018.
- 3.2 With regards to the update report on Cookham Wood Young Offenders Institution, at the meeting it was agreed that the Committee would be provided with a briefing note concerning the Council's statutory position and the updated arrangements in relation to the Young Offenders Institution. Should Members require further detail following receipt of the briefing note then a further report can be requested to be brought to the Committee at a later date to which it may be advisable to invite the Governor.

- 3.3 In accordance with the Council's Overview and Scrutiny Rules, set out at Chapter 4, Part 5, Paragraph 9.1 of the Council's constitution, Members were advised that Councillor Johnson had requested that an item concerning the University Technical College (UTC) be included on the agenda for 5 June 2018. Officers advised Members that only a high level information report regarding the findings of the Ofsted report would be available for this meeting and it was discussed and recommended that this item be deferred to the July meeting when the UTC had an Improvement Plan in place which would allow for a much more detailed report to be presented. Councillor Johnson has agreed for this item to be deferred to 31 July so that full discussion may take place.

5. Headteacher position on the Committee

- 5.1 On 8 December 2015 the Committee considered a report regarding membership issues including changes to the Headteacher and Teacher positions on the Committee. The recommendations from this were forwarded to Council, which agreed the following on 21 January 2016: -
 - To continue with places on the committee for one Headteacher and one teacher but, where possible, depending on expressions of interest received, require one to be employed in a primary school and one in a secondary school.
 - Where possible, depending on expressions of interest received, one Headteacher/teacher place is a designated for a person working in a local authority maintained primary school in Medway and the other to a person working in a non-maintained, for example, an academy.
 - That a selection criteria be used to assess the expressions of interest received for selection to the two positions (as attached at Appendix 2)
 - That expressions of interest be invited via the School Information Bulletin and that the Director of Children and Adults Services consider each against the selection criteria (Appendix 2). The Director should then, in consultation with the Chairman, Vice-Chairman and Opposition

- Spokespersons of the Children and Young People O&S Committee, forward recommendations to this Committee for onward referral to Council for approval.
- Appointments be made for a two year term and the types of schools represented by the Headteacher and Teacher be rotated and reappointed to after each two year term.
- 5.2 Tina Lovey, Headteacher of Rivermead School and Chief Executive Officer of the Rivermead Inclusive Trust, was appointed to the Headteacher position on 13 June 2016 for a two year term. Her term of office therefore expires on 13 June 2018.
- 5.3 An invitation for expression of interests into the vacancy will be published in the School Information Bulletin after the half term break. Should more than one expression of interest be received, then the selection process will be carried out as detailed above in 5.1. An update on this will be provided in the work programme report on 31 July 2018.

6. Implications for Looked After Children

6.1 Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent you should be a champion for looked after children and have the same high expectations of them as you would for your child, grandchild or niece/ nephew.

7. Financial and legal implications

7.1 There are no financial or legal implications arising from this report.
