Summary

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives Members the opportunity to shape and direct the Committee's activities over the year.

1. Budget and Policy Framework

1.1 Under Chapter 4, Part 5 of the Constitution – Overview and Scrutiny Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny Committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 15 November 2018.
- 3.2 At the meeting, the following was suggested:
 - 3.2.1 To defer the Sufficiency Statement 2018 from the December meeting to the meeting of the Committee scheduled for 10 January 2019.
 - 3.2.2 To defer the update report on tackling racism from the January meeting to the meeting due to be held in May/June 2019.

- 3.2.3 That a report on the outcomes of the Medway Youth Council's Annual Conference be scheduled for the May/June 2019 meeting of the Committee.
- 3.2.4 That a report in relation to Governor Services be added to the 10 January 2019 meeting, following the recommendation from Audit Committee that the arrangements of the provision should be raised with this Committee.
- 3.2.5 That the demonstration of the Mind of My Own (MOMO) app be provided through member development after the forthcoming local elections.
- 3.2.6 That a briefing note being circulated to members of the Health and Adult Social Care (HASC) Overview and Scrutiny Committee relating to the Medway Children and Young People Emotional Wellbeing Service also be shared with this Committee (this was also a recommendation from the HASC Overview and Scrutiny Committee).
- 3.3 At the meeting, officers also indicated that they were likely to report a draft Children and Young People's Plan to the January meeting and a report regarding proposed safeguarding partnership arrangements to the March meeting of the Committee.

5. Headteacher position on the Committee

- 5.1 The Headteacher position became vacant on 13 June 2018 when the previous post holder, Tina Lovey, came to the end of her two year term of office.
- An invitation for expression of interests into the vacancy was emailed to all Medway Headteachers on 14 September 2018, with a closing date of 19 October. During this period one expression of interest was received from Nicola Forrest, Headteacher at New Road Primary School. Nicola is currently in her fourth headship and has a "career history of rapid improvement".
- 5.3 The Committee is requested to consider the expression of interest and recommend the appointment of Nicola Forrest to the Headteacher position of the Children and Young People Overview and Scrutiny Committee for a two year term.

6. Teacher position

6.1 The recent post holder for the teacher position, Fay Cordingley, is changing roles on the Committee. Fay has recently agreed to be the Church of England Diocese of Rochester's representative on the Committee, which has been a long term vacancy. This therefore creates a vacancy in the teacher position and Democratic Services will be inviting expressions of interest to this vacancy shortly.

7. Implications for Looked After Children

7.1 Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent, Members should be a champion for looked after children and have the same high expectations of them as they would for their own child, grandchild or niece/ nephew.
