# ESTABLISHMENT OF COMMITTEES, APPOINTMENTS AND SCHEDULE OF MEETINGS 2019/2020

### Summary

The Council is asked to determine the committees and other bodies to be appointed for 2019/2020, to agree the appointment of Members to serve on committees and other bodies and a programme of meetings.

The Council is also asked to make recommendations to the Joint Meeting of Committees on 22 May 2019, immediately following the Annual Meeting of the Council, in respect of the appointment of Chairmen and Vice-Chairmen of committees and the establishment and membership of sub-committees.

### 1. Budget and Policy Framework

- 1.1 The establishment of committees and the appointment of Members to serve on committees and outside bodies is a matter for decision by the Annual Meeting of the Council together with approval of the annual schedule of meetings.
- 1.2 The appointment of Chairmen and Vice-Chairmen of Committees, the establishment of sub-committees and the appointment of Members to serve on them is a matter for decision at a Joint Meeting of Committees, which immediately follows the Annual Council Meeting.

## 2. Background

2.1 Local elections for all 55 Councillors representing 22 Wards took place on 2 May 2019. The composition of the Council is now as follows:

## 3 Establishment of Committees and allocation of seats plus other appointments for 2019/2020

- 3.1 The Local Government and Housing Act 1989 requires the Council to allocate seats on committees to political groups in accordance with the size of each group on the Council as a whole, unless alternative arrangements are notified to all Members five clear days in advance of the Council meeting and agreed without any Councillor voting against them. The Council is required to observe the following principles so far as is reasonably practicable:-
  - (a) that not all the seats on the body are allocated to the same political group;
  - (b) that the majority of the seats on the body is allocated to a particular political group if the number of persons belonging to that group is a majority of the authority's membership;
  - (c) subject to paragraphs (a) and (b) above, that the number of seats on the ordinary committees of a relevant authority which are allocated to each political group bears the same proportion to the total of all the seats on the ordinary committees of that authority as is borne by the number of members of that group to the membership of the authority;
  - (d) subject to paragraphs (a) to (c) above, that the number of the seats on the body which are allocated to each political group bears the same proportion to the number of all the seats on that body as is borne by the number of members of that group to the membership of the authority.
- 3.2 Principles (a), (b) and (d) apply to <u>all</u> appointments to the authority's own bodies and to certain outside bodies. However, principle (c) only relates to appointments to the 'ordinary committees' of the council.
- 3.3 Formal notices of the formation of Conservative and Labour political groups have been received in the prescribed format.

- 3.4 A proposal for the establishment of committees, their size and the allocation of seats to political groups has been put forward by the Conservative Group Whip and is set out in Appendix A. This has been discussed with the Labour Group Whip and notified to both Independent Councillors. The proposal meets the overriding requirement to ensure the overall number of seats on ordinary committees are allocated in accordance with the political balance of the Council. The proposal recommends 138 committee seats overall, reflecting a proposed increase in the size of the four Overview and Scrutiny Committees from 13 to 14 seats and the inclusion of the Governor Ad-Hoc Committee as a politically balanced Committee.
- 3.5 There must be three additional Conservative Group Members on the Children and Young People Overview and Scrutiny Committee to preserve that Group's majority in view of the four statutory co-optees with voting rights who have to be appointed to the Committee.
- 3.6 Column 5 of Appendix A identifies the committee seats that cannot be allocated to the political groups. If the Independent Councillors form a Group they would be entitled to these seats. Otherwise, it is recommended by the Conservative Group Whip that these seats remain as vacancies.
- 3.7 The Health and Wellbeing Board is a Committee of the Council. This Committee is not subject to the rules on political balance and the Council has previously agreed that the positions of Chairman and Vice Chairman of the Board should be appointed by the Board at its first ordinary meeting after each Annual Council meeting rather than at the Joint Meeting of Committees on the evening of Annual Council.
- 3.8 The current list of committees, joint committees, outside bodies, subcommittees and task groups are set out in Appendices B and C with recommended sizes and allocation of places. The names of Members and others to be appointed to these bodies will follow in a supplementary agenda.
- 3.9 In addition to the proposal for the establishment and composition of Committees as set out in Appendix A to the report, some variations to the composition of sub-committees and other bodies as listed below are either recommended or required to comply with legal requirements or align with established practice in light of the new political balance of the Council. The Council is, therefore, asked to approve the composition of the bodies listed below as follows, as discussed with both Group Whips:
