ESTABLISHMENT OF COMMITTEES, APPOINTMENTS AND SCHEDULE OF MEETINGS 2010/2011

Summary

This report sets out the position regarding the overall allocation of seats on committees. The Council is asked to determine the committees and other bodies to be appointed for 2010/11, to agree the appointment of members to serve on committees and other bodies and a programme of meetings.

The Council is also asked to make recommendations to the Joint Meeting of Committees on 19 May 2010, immediately following the annual meeting of the Council, in respect of the appointment of Chairmen and Vice-Chairmen of committees and the establishment and membership of sub-committees and task groups.

1. Budget and Policy Framework

- 1.1 The establishment of committees and the appointment of Members to serve on committees and outside bodies is a matter for decision by the Annual Meeting of the Council together with approval of the annual schedule of meetings.
- 1.2 The appointment of Chairmen and Vice-chairmen, the establishment of sub-committees, task groups and the appointment of Members to serve on them is a matter for decision at a Joint meeting of Committees, which immediately follows the Annual Council meeting.

2. Background

2.1 The Council considered the position regarding the overall allocation of seats on committees at its meeting on 15 April 2010 and agreed recommendations for decision at the Annual Council meeting on 19 May 2010.

3 Establishment of Committees and allocation of seats plus other appointments for 2010/2011

- 3.1 The Local Government and Housing Act 1989 requires the Council to allocate seats on committees to political groups in accordance with the size of each group on the Council as a whole, unless alternative arrangements are notified to all Members and agreed without any Councillor voting against them. The council is required to observe the following principles so far as is reasonably practicable:-
 - (a) that not all the seats on the body are allocated to the same political group;
 - (b) that the majority of the seats on the body is allocated to a particular political group if the number of persons belonging to that group is a majority of the authority's membership;
 - (c) subject to paragraphs (a) and (b) above, that the number of seats on the ordinary committees of a relevant authority which are allocated to each political group bears the same proportion to the total of all the seats on the ordinary committees of that authority as is borne by the number of members of that group to the membership of the authority;
 - (d) subject to paragraphs (a) to (c) above, that the number of the seats on the body which are allocated to each political group bears the same proportion to the number of all the seats on that body as is borne by the number of members of that group to the membership of the authority.
- 3.2 Principles (a), (b) and (d) apply to <u>all</u> appointments to the authority's own bodies and to certain outside bodies. However, principle (c) only relates to appointments to the 'ordinary committees' of the council.
- 3.3 Any decision to waive the requirements of political balance will require a resolution of the council with no member voting against.
- 3.4 The political balance of the Council is currently as follows:

3.5 The following table sets out proposals discussed with Party Group Whips, for the establishment of committees, their size and the allocation of seats to political groups. This meets the overriding requirement to ensure the overall number of seats on ordinary committees are allocated in accordance with the political balance of the Council.

Notes:

(i) The proposal discussed by Group Whips involves the Conservative Group relinquishing one seat on the Licensing and Safety Committee and one on the Business Support Overview and Scrutiny Committee, creating one

- vacancy on each of these Committees to which none of the other Political Groups are entitled. The Independent Member has no right to any seats.
- (ii) *There are two additional Conservative Members on the Children and Adults Overview and Scrutiny Committee to preserve that Group's majority in view of the four statutory co-optees with voting rights who have to be appointed to the Committee
- 3.6 The Council has also previously approved the establishment of an ad hoc committee to consider the removal of Council appointed school governors as and when necessary and that the membership of the committee is comprised of the Group Whips and the relevant Portfolio Holder. Previously political balance has been waived in respect of this committee so that the overall number of seats on committees is not affected. Therefore it has not been included in the calculation set out above.
- 3.7 The current list of committees, joint committees, outside bodies, subcommittees and task groups are set out at Appendices A and B with recommended sizes and allocation of places. (Note: These appendices will follow under separate cover once all party groups have supplied their lists of nominations).

4. Timetable of meetings

4.1 On 15 April 2010 the Council reviewed and agreed to recommend the draft schedule of meetings for 2010/2011, as attached at Appendix C. Changes incorporated since the draft timetable were presented to the council in January were reported and have been included in this final version.

6. Recommendations

- 6.1 The Council is asked to agree:

 - the establishment of an ad hoc committee to consider the removal of Council appointed school governors as and when necessary and to waive political balance in respect of this Committee;
 - (iii) the membership of each committee as set out in Appendix A to this report, including the appointment of voting and non-voting co-optees on committees as listed

- (iv) appointments to Joint Committees and other bodies as set out in Appendix B to this report;
- (v) the timetable of meetings for the 2010/2011 municipal year as set out in Appendix C to this report
- 6.2 The Council is asked to recommend to the Joint meeting of Committees:
 - (i) the appointment of Chairmen and Vice Chairmen of Committees
 - (ii) the establishment of sub committees (with terms of reference as set out in the Council's constitution), task groups, their size and the allocation of seats to political groups as set out in Appendix A to this report.
