Summary

This report advises Members of the current work programme and allows them to adjust it in the light of latest priorities, issues and circumstances and provides an opportunity to shape and direct the Committee's activities over the year.

1. Budget and Policy Framework

1.1 Under Chapter 4 – Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the existing work programme for this Committee. One of the Committee's functions is to provide guidance and leadership on the development and co-ordination of the scrutiny function for all Overview and Scrutiny Committees. Appendix 2 sets out the work programmes for the other Overview and Scrutiny Committees.

3. Agenda Planning Meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information Members wish them to provide when scrutinising an issue. The agenda planning meeting took place on 6 June attended by the Chairman, Vice-Chairman and Opposition Spokesperson.
- 3.2 Members discussed the Committee's work programme and agreed the following:
 - a) that the Committee be recommended to add the following items to the work programme for pre-decision scrutiny:

- Housing Allocations Policy 22 August
- Draft Homelessness and Rough Sleeping Strategy 24 October
- Housing Enforcement and Licensing Policy 28 November
- b) that a report on new Statutory Guidance on Overview and Scrutiny in Local and Combined Authorities be added to the agenda for this meeting (see agenda item 7).
- c) that an update on a public rights of way claim following the sale of Council land at New Road, Chatham (previously considered by the Committee in April and August 2018) and, also, the topic for the next Task Group be included in this report (see paragraphs 3.4-3.7 and 3.8-12).
- 3.3. Members also asked the Chief Legal Officer to arrange a briefing for new Members on Medway Commercial Group, Medway Norse, Medway Development Company and the shared services arrangements the Council has entered into in recent years and, also, for a briefing on the Council's property portfolio, including the rationale for the recent purchase of the Pentagon Centre.

Public rights of way claim at New Road, Chatham

- 3.4 The Committee considered a Member's item in April 2018 concerning the freehold disposal of land adjoining Union Place Car Park, New Road, Chatham and requested an update on the issue of the possible right of way in respect of land adjoining the car park and also requested planning officers to investigate whether the fences and gates erected by the new owner required planning permission.
- 3.5 The Committee considered a progress report on the status of this rights of way claim in August 2018. At that point officers were still investigating the matter and no decision on the status of the claim had been made. Members therefore asked for a further progress report when there were further developments, and also recommended that the Head of Planning take enforcement action in respect of the gates and fences already erected on the land, having been advised that these required planning permission.
- 3.6 Officers have now successfully secured a permissive path agreement with the landowner and identified funds to make the route safe for pedestrians. These works took place in late March and the path is now open for use for people who use the local businesses.
- 3.7 The issue of the fences and gates was investigated by planning officers. Technically, as both exceed 2 metres in height then planning permission should have been obtained. However, as they are only slightly above 2 metres in height and given the landowner's co-operation in helping to agree the permissive path agreement, it was not felt it would be a good use of public money to take enforcement action as the appearance of any replacement fences and gates would not be materially different.

Task Groups

- 3.8 In November 2017, following a criteria based selection process, this Committee agreed that the next round of Task Group topics should be as follows in priority order:
 - Review 1: The Impact of Social Isolation for the Council (Health and Adult Social Care Overview and Scrutiny Committee).
 - Review 2: Support for Carers (Health and Adult Social Care/Children and Young People Overview and Scrutiny Committees).
 - Review 3:Physical Activity (Health and Social Care, Children and Young People, Regeneration, Culture and Environment Overview and Scrutiny Committees.
 - Review 4: Town Centres for the 21st Century (Regeneration, Culture and Environment and Business Support Overview and Scrutiny Committees).
- 3.9 <u>The Impact of Social Isolation Task Group</u> completed its work in January 2019.
- 3.10 At the agenda planning meeting for this Committee meeting it was agreed to recommend that Physical Activity should be the subject of the next Task Group Review, followed by Town Centres, on the basis that a new Joint Carers Strategy 2019-2024 was adopted by the Cabinet and Medway CCG in June 2019 and it would be more timely to undertake a review of progress against the six key priorities in the Strategy once the joint delivery plan has been developed and implemented. It would be too early at this time for carers and other stakeholders to provide feedback on their experience in the context of the new Strategy.
- 3.11 For ease of reference the rationale and criteria based assessments for topics2-4 in the current programme of Task Group reviews are attached at Appendix3.
- 3.12 If the Committee approves Physical Activity as the next Task Group review it is recommended that the Task Group should comprise 7 Councillors (4 x Conservative and 3 x Labour) drawn from the Health and Adult Social Care (HASC), Children and Young People (CYP) and Regeneration Culture and Environment (RCE) Overview and Scrutiny Committees as follows with the HASC Overview and Scrutiny Committee designated as the lead Committee:
 - HASC O&S Committee 2 Con (one of whom will be Chairman of the Task Group) and 1 Lab
 - CYP O&S Committee 1 Con and 1 Lab
 - RCE O&S Committee 1 Con and 1 Lab

Portfolio Holders - Holding to Account

- 3.13 On an annual basis each Portfolio Holder is held to account by the relevant O&S Committee(s) on matters within their portfolio. The proposed timetable for this Committee is as follows:
 - Leader of the Council April 2020
 - Deputy Leader and Portfolio Holder for Community Services January 2020
 - Portfolio Holder for Business Management October 2019
 - Portfolio Holder for Resources November 2019

 - consideration of petitions
 - consideration of called-in Cabinet decisions.
- 5.3 Appendix 2 to this report sets out the current work programmes of the other three overview and scrutiny committees.

7. Recommendations

 - (c) agree that Physical Activity should be the topic for the next Scrutiny Task Group review with a membership of 7 Councillors (4 x Conservative and 3 x Labour) drawn from the Health and Adult Social Care (HASC), Children and Young People (CYP) and Regeneration Culture and Environment (RCE) Overview and Scrutiny Committees, noting that the HASC Overview and Scrutiny Committee will be the lead Committee;

- (d) authorise the Head of Democratic Service to appoint the Members of the Physical Activity Task Group once nominations have been received from Group Whips in consultation with the relevant Overview and Scrutiny Committee Chairmen and Opposition Spokespersons;
- (e) agree to add the following items to the work programme for pre-decision scrutiny:

 - Draft Homelessness and Rough Sleeping Strategy 24 October
 - o Housing Enforcement and Licensing Policy 28 November
