Summary

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives Members the opportunity to shape and direct the Committee's activities over the year.

1. Budget and Policy Framework

1.1 Under Chapter 4, Part 5 of the Constitution – Overview and Scrutiny Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny Committee has the responsibility for setting its own work programme.

2. Background

2.1 Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.

3. Agenda planning meeting

- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 12 February 2020.
- 3.2 At the meeting it was requested that officers circulate a draft of the Annual School Performance Report, ahead of the main despatch, in order to give the Committee Members ample time to fully digest the detail.
- 3.3 At the meeting a number of suggestions were made about the future scrutiny of children's services, which are included in section 5 below.

4. Cabinet Forward Plan

5. Scrutiny of Children's Services

- 5.1 Following an inspection of Children's Services in July 2019, OFSTED commented that whilst governance arrangements in Medway are clearly delineated and the commitment to improving services is apparent, there is insufficient analysis and understanding of underlying complexities and continuing risks to children. In her December 2019 report to the Minister of State for Children and Families, the Commissioner for Children's Social Care in Medway stated that going forward the role of scrutiny needs to be strengthened, and more training provided for the wider group of members on children's issues and their role as ward councillors, if they are to deliver on making a real difference for children.
- 5.2 In response to this feedback work is underway to create a framework for ongoing member development and new ways of working that will maximise the impact of the activities of Councillors involved in overview and scrutiny of Children's Social Care.
- 5.3 As a starting point, guidance produced by the Centre for Public Scrutiny (CfPS) on how to effectively scrutinise children's safeguarding and services for looked after children has been circulated to all Members of the Council. In summary the guidance says that in order to provide effective scrutiny of children's social care, overview and scrutiny members should be clear that their fundamental role is to make sense of local performance and to champion the interests of children. The guidance says a good scrutiny function requires members to have knowledge of:
 - the principles and practice of safeguarding and child protection (with knowledge about quality of practice as well)
 - how local safeguarding arrangements are managed and structured
 - how to put the child at centre stage in Scrutiny and how to test the
 extent to which there is a commitment to listening and understanding the
 experience of children within Children's Services the experience of the
 child "shining through" in assessments for example
 - how to navigate complex systems of multiple agencies and organisations
 - how to work collaboratively with partners and stakeholders whilst maintaining critical challenge
- 5.4 A speedy informal review has been undertaken of the arrangements in place for scrutiny of children's social care in nine other local authority areas (including a number of Councils that have recently progressed from an inadequate OFSTED judgement to good or outstanding) to identify any common themes or differences of practice compared to the arrangements in Medway. Whilst there is some variability in the scrutiny arrangements in place in these nine local authorities, there are some common themes including; regular access by scrutiny members to detailed performance information which drives the choice of topics for in-depth scrutiny, regular engagement with young people in both Committee meetings and Task Group work and regular updates to overview and scrutiny on progress with implementation of the improvement action plan in those Council's judged to be inadequate for children's social care.

5.5 Drawing on the CfPS guidance, what we have seen working well in other local authority areas and ideas put forward by Medway Members over the last few weeks it is proposed to move forward with new ways of working as set out below with the aim of demonstrating, at pace improved capacity for impact by overview and scrutiny. This will be in addition to the inclusion of a progress report on the implementation of the Medway Children's Services Action Plan at every meeting of the Committee:


6. Selection of topics for a Task Group and themed meeting(s)

- 6.1 The Council has agreed that up to three in-depth scrutiny Task Groups or themed Overview and Scrutiny Committee meetings can be supported in total across all four of the Council's Overview and Scrutiny Committees every year with each review running successively. The Business Support Overview and Scrutiny Committee has a co-ordinating role, inviting the nomination of topics from each Committee and then prioritising them on the basis of a criteria based selection process which reflects national best practice.
- 6.2 The current round of topics with an indicative timeline is as follows:

Topic	Timeline (approx 20 weeks per review)
Review 1: The Voluntary Sector	November 2019 to March 2020
Review 2: Physical Activity	April 2020 to August 2020
Review 3: Town Centres	September 2020 to January 2021
Review 4: Support for Carers	February 2021 to June 2021

- 6.3 Given that the improvement of children's social care is a priority for the Council during 2020 the Committee is recommended to ask the Business Support Overview and Scrutiny Committee to agree that the next Task Group should focus on a topic related to children's social care and that one of the Children and Young People Overview and Scrutiny Committee meetings should be a themed meeting on a related topic. This would mean delaying the start of a Task Group on Physical Activity until later in the year.
- 6.4 Clearly any in-depth scrutiny review work at this time should compliment rather than duplicate activity already underway to deliver the Medway Children's Services Action Plan. The Committee will want to review options for topics that will add value and contribute to children's services improvement journey.
- 6.5 As a guide the selection criteria used for selecting Scrutiny Task Group topics is as follows:

- 6.6 There are multiple action points in the Medway Children's Improvement Plan under the five key priorities:
 - Quality and effectiveness of Practice
 - Capacity and capability of our workforce
 - Effective leadership and management
 - Quality Assurance and Performance Management and
 - Partnerships and Engagement
- 6.7 Taking into account current progress against the actions in the Improvement Plan and what current performance data is telling us the Director of People has

suggested the Committee might wish to select a task group topic relating to early help. The Council is working with Essex County Council as a Partner in Practice on early help services in Medway. Medway are currently awaiting the outcome of a diagnostic report from Essex County Council on the service.

7. Implications for Looked After Children

7.1 Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent, Members should be a champion for looked after children and have the same high expectations of them as they would for their own child, grandchild or niece/ nephew.

8. Financial and legal implications

8.1 There are no financial or legal implications arising from this report.

9. Recommendations

- 9.1 The Committee is asked to agree the work programme as set out at Appendix 1 to the report, subject to accepting the proposed changes, outlined in italic text on Appendix 1.
- 9.2 The Committee is asked to consider and support the new ways of working outlined in Section 5 of the report with a view to strengthening scrutiny impact particularly in performance monitoring.
- 9.3 The Committee is asked to recommend the Business Support Overview and Scrutiny Committee to agree that the next Scrutiny Task Group should have focus on Children's Social Care and that there should be an option of one Children and Young People Overview and Scrutiny Committee in 2020/21 being a themed meeting also with a focus on children's social care.
- 9.4 Subject to the agreement of the Business Support Overview and Scrutiny Committee, this Committee is asked to agree that a Task Group comprising three Conservative and 2 Labour and Co-operative Group members should be set up to undertake an in-depth scrutiny review.
- 9.5 The Committee is asked to agree that the Task Group should focus on Early Help and that the Head of Democratic Services should be authorised to develop the detailed scope of the review in consultation with the Task Group members once the findings of the diagnostic exercise undertaken by Essex County Council are available, as set out in section 6.7.
