LICENSING ACT 2003 - APPLICATION FOR A NEW PREMISES LICENCE, MEDWAY FOOD CENTRE

Summary

The applicant has applied for a new Premises Licence in respect of Medway Food Centre, 43-45 Luton High Street, Chatham, ME5 7LP.

All responsible authorities have been consulted in line with the Licensing Act.

Representations have been received from members of the public, the Police, Public Health, a local charity Big Local and Ward Councillors, together with a petition. No agreements have been reached.

1. Budget and policy framework

1.1. Medway Council has published its Statement of Licensing Policy, which it takes into account in all applications relating to the Licensing Act 2003. These premises fall within a Cumulative Impact Policy (CIP) area. When the CIP is applied, and there are relevant representations, there is a rebuttable presumption of refusal by the Authority in all but exceptional circumstances, unless the applicant can demonstrate the premises will not adversely affect the licensing objectives.

2. The Application

- 2.1. In accordance with the Licensing Act 2003, the Council has received an application for a new Premises Licence in respect of Medway Food Centre, 43-45 Luton High Street, Chatham, ME5 7LP.
- 2.2. The details of the application requirements are as follows:

Supply of Alcohol (off the premises)

Monday to Sunday 09:00 – 20:00

2.3. A copy of the original application as submitted is at Appendix A.

- 2.4. The application has been correctly advertised in the local press and notices displayed on the premises for the required period.
- 2.5. A copy of a map showing the location of the premises is at Appendix B
- 3. Promotion of the Licensing Objectives.
- 3.1 The applicant is expected to demonstrate that they have dealt with and understand the promotion of the four licensing objectives, where appropriate. Members are referred to section M of the application at Appendix A.
- 3.2 The four licensing objectives are:
 - the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - the protection of children from harm

4 Relevant Representations

4.1 This matter has been put to the Licensing Hearing Panel because the Council has received representations relating to all four of the licensing objectives from members of the public, Police, Public Health, Ward Councillors, a local charity Big Local, together with a petition. Copies of these are attached at Appendix C. To date no agreement has been reached.

5 Policy Considerations

- 5.1 Medway Council has published its Statement of Licensing Policy, which it will consider alongside the amended Guidance issued by the Home Office under section 182 of the Licensing Act 2003 in all applications.
- In determining this application, Members may wish to consider information contained in Appendix 7 to the Statement of Licensing Policy that lists examples of good practice against the four licensing objectives as well as Chapters 9 and 10 of the amended Guidance.
- 5.3 As the premises in the application fall within a CIP area, Members should also refer to Chapter 6 and Appendix 4 of the Statement of Licensing Policy.

6 Risk Management

6.1 The Council has to consider and determine this application, which is a function relating to licensing and registration as set out in Schedule 1 to the Functions Regulations, the Licensing Act 2003, the Gambling Act 2005 and other licensing functions reserved by law to the Council's Licensing and Safety Committee and its Sub-Committees, in accordance with the law (both

statutory and case law), relevant statutory guidance and statements of policy.

- 7 Financial and legal implications
- 7.1 There are no direct financial or legal implications at this time.
- 7.2 This hearing is regulated by the Licensing Act 2003 (Hearings) Regulations 2005 (as amended).
- 7.3 There is the possibility of a challenge by way of appeal to the decision by either the applicant or objectors should either have the requisite grounds to do so. Legal advice will be given to Members as appropriate at the meeting. However, whatever the decision of the Panel, this must be based on the evidence placed before it in line with the licensing objectives and the Panel must decide what weight to attribute to this information.

8 Recommendation

8.1 That the Licensing Hearing Panel, having regard to the Licensing Act 2003, the statutory guidance issued under S182, the Council's Statement of Licensing Policy and all matters before it, both written and oral, considers and determines this application for a premises licence.

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The application recognises the CIP (Cumulative Impact Policy) and feels that there would be no additional adverse effect with the application with proposed conditions within the application and the nature of the venue. This operating schedule and its conditions would aim to enhance compliance with CIP and current licensing policy with revised conditions and hours.

Hours 9am to 8pm only

Alcohol sales must be ancillary to grocery

Not to display signage advertising alcohol or 'off license' sales on shop frontage

The licence holder and/or designated premises supervisor shall ensure that at least one personal licence holder is available on the licensed premises while the sale or supply of alcohol is being undertaken at the premises.

- Minimum of 2 staff on duty after 6pm until licensed hours finish
- No cans to be sold singular only multipack
- No miniature bottles of spirit to be sold
- No high strength beers/larger/cider to be stocked above 6% ABV
- Alcohol section to be locked via shutter outside licensing hours
- Clear signage will be displayed showing permitted hours and condition that alcohol is ancillary to grocery sale
- Challenge 25 sale procedure in place with signage
- Signage in place reminding shop users to leave quietly at all times and also that any persons seen to consume alcohol in the immediate area would be excluded from future purchase at the shop
- No 'credit' sale is to be permitted
- All incoming stock will be UV checked for authenticity using the HMRC mark
- Daily rubbish clearance in immediate vicinity of the shop
- Display signage at the shop promoting local residents to alert the DPS of ASB in the immediate area
- DPS to maintain an exclusion record as required for any person who is known for alcohol ASB
- CCTV Condition as detailed in prevention of crime and disorder

b) The prevention of crime and disorder

CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions particularly facial recognition.

- Cameras shall encompass all ingress and egress to the premises, fire exits and all areas where the sale and supply of alcohol occurs.
- Equipment must be maintained in good working order, be correctly time and date stamped, recordings MUST be kept on the hard drive and kept for a period of 28/31 days and handed to Police upon reasonable request.
- The premises licence holder must ensure at all times a DPS or appointed member of staff is capable and competent at downloading CCTV footage in a recordable format to the Police and Local Authority upon reasonable request.
- In the event of technical failure of the CCTV equipment the premises licence holder or DPS must report the failure to the Police Licensing Officer within 24 hours unless the CCTV will be repaired before that time (licensing.north.division@kent.pnn.police.uk)

The License Holder will maintain auditable refusal/incident records. These records will detail the following;

- a. Day, Date and Time of Refusal/Incident.
- b. Nature of Refusal/Incident and reason.
- c. Details of or description of the individual.
- d. Each entry is to be checked and signed by the D.P.S or personal license holder on duty, on the day of the event
- e. These records will be made available for inspection to any Police Officer, Police Licensing Officer, and Officer of the Local Authority immediately upon demand.

Alcohol sales to cease at 8pm

c) Public safety

All persons that sell or supply alcohol to customers must have licensing training.

- Training should take place within six weeks of employment and any new employees will be supervised until the training has taken place.
- Refresher training should be repeated a minimum of every six months or earlier if required due to changes of legislation.
- Training records must be kept on the premises and shall contain the nature, content and frequency of all training.
- Records must be made available for inspection by Police, Police Licensing Officer and authorised officers from the Local Authority on demand either electronically or hard copy.
- Alcohol is only sold with a grocery purchase
- Challenge 25 ID policy and procedure in place
- All refusals recorded as detailed

d) The prevention of public nuisance

- Display signage at the shop promoting local residents to alert the DPS of ASB in the immediate area
- DPS to maintain an exclusion record as required for any person who is known for alcohol ASB
- Clear signage will be displayed showing permitted hours and condition that alcohol is ancillary to grocery sale
- Clear glass shop frontage alongside CCTV to enable staff to monitor area nearby- Daily rubbish clearance in immediate vicinity of the shop
- Alcohol sales to cease at 8pm

e) The protection of children from harm

- Alcohol is only sold with a grocery purchase
- Challenge 25 ID policy and procedure in place
- All refusals recorded as detailed

All persons that sell or supply alcohol to customers must have licensing training.

- Training should take place within six weeks of employment and any new employees will be supervised until the training has taken place.
- Refresher training should be repeated a minimum of every six months or earlier if required due to changes of legislation.
- Training records must be kept on the premises and shall contain the nature, content and frequency of all training.

The licence holder and/or designated premises supervisor shall ensure that at least one personal licence holder is available on the licensed premises while the sale or supply of alcohol is being undertaken at the premises.

Sale of Alcohol from 9am outside or morning school transit hours.





Please give the reason for the representation and detail the evidence supporting it under the appropriate headings:

Kent Police are objecting to this application for a premises licence under all four licensing objectives and therefore ask the Licensing Committee to refuse this application.

Medway Council resolved that a Cumulative Impact Policy be adopted including the area of Luton High Street and Luton Road. This has been incorporated into the Authority's current Statement of Licensing Policy.

The policy creates a rebuttable presumption that any new applications for premises licences or club premises certificates, along with any major variations that could impact negatively on the licensing objectives will be refused, in all but exceptional circumstances unless the applicant can demonstrate that there will no negative impact on any of the licensing objectives.

Further to this Luton High Street suffers from high intoxication levels. This has led to alcohol related crime taking place. Ranging from violence against the person, shop lifting, robberies etc. It is acknowledged that the applicant does not in any means want to contribute to this, however the increased availability of alcohol in this area would undoubtable further fuel alcohol related issues.

The location of Luton High Street attracts a number of street drinkers. A street drinker is defined as a person who drinks heavily in public places and, at least in the short term, is unable or unwilling to control or stop their drinking, has a history of alcohol misuse and often drinks in groups for companionship (Lamb, 1995). People who are street drinkers are likely to be at increased risk of causing harm to themselves or others and may be involved in antisocial behaviour such as begging, or rowdy drunken behaviour that can be intimidating or even violent.

There is strong evidence concerning street drinking associated nuisance and anti - social behaviour and the availability of alcohol, particularly from off licences. The Medway Task Force and Police Licensing Team have been working in the area and can confirm there are still alcohol related issues in the area.

Kent Police feel that should a premises licence be granted to this store that the increased availabilities of alcohol in the area could in turn can lead to crime and disorder and public nuisance and people feeling unsafe living in their community.

There have been issues with local youths who are reported to gather in the area and cause issues, often alcohol lead.

1) Prevention of Crime and Disorder

This area of Luton is a high priority area for Kent Police due to the levels of both crime and anti-social behaviour. Street Drinkers are persons who tend to be alcohol dependant and will drink alcohol in public. Street drinking and associated antisocial behaviour can impact on people's perception of the physical environment and more importantly their quality of life and safety. Groups of drinkers can sometimes be intimidating and stop people using public spaces or facilities and live in fear of crime.

2) Public Safety

Much of the representations that have been made in respect of the impact on the Licensing Objective of Crime & Disorder can be mirrored under this objective. Any incident of Public Order or assault has the potential to impact on Public Safety, through the protagonists and their interaction with Police.

3) Prevention of Public Nuisance

Public nuisance under the Licensing Act enables the interpretation of nuisance to retain its wider meaning under common law. It therefore retains the breadth and flexibility to take in all the concerns likely to arise from the operation of any premises conducting licensable activities in terms of the impact of nuisance on people living or doing business nearby.

Any incidents that Kent Police responds to are by definition a nuisance to some section of our community. Those that engage in anti-social behaviour and crime brought about by excessive uncontrolled consumption of alcohol are a public nuisance.

4) Protection of Children from harm

The hours that the applicant is seeking are 09:00 until 20:00. There is school and nursery within walking distance of the proposed off licence for children aged 3-11 years old. Some of these children are from deprived backgrounds and some experience alcohol abuse as part of their family life. The children often see and hear the street drinkers who congregate on the green area of Alexandra Road, which is within easy walking distance of the applicants off licence. The obscene language they use, the litter they leave, along with public urination and harassment of passers-by is a public nuisance. The local Police and PCSO's believes granting this licence will add to this problem.

Kent Police do not believe there are any meaningful conditions that can be put on the licence that will ensure that the four licensing objectives are being promoted. Another premises permitted for off sales will not assist in an already saturated area and respectfully request that due to the amount of alcohol related harm in this area that this application is refused.

LICENSING ACT 2003 – GRANT OF A PREMISES LICENCE APPLICATION

Name and address of premises

Medway Food Centre, 43-45 Luton High Street, Chatham. ME5 7LP

The Director of Public Health is making representations concerning an application for the grant of the above premises licence. The representations are made against the following licensing objectives:

- The prevention of crime and disorder
- The prevention of public nuisance

General comments

This premises is located in a small line of shops in Luton High St, within a densely residential area. The road is busy, leading from Chatham and Luton Road into the residential areas of Capstone, Princes Park and Walderslade. This is one of the most deprived areas of Medway.

This premises is located within the Luton cumulative impact policy (CIP) area which covers Luton Road, Luton High St, and parts of Chatham Central ward. The evidence accepted by the Authority to support the CIP (available at https://democracy.medway.gov.uk/mgConvert2PDF.aspx?ID=3440&T=10) is relevant to this application. There is strong evidence of high levels of alcohol related crime, disorder and public nuisance associated with a density of off-licensed premises in the Luton CIP area.

The prevention of crime and disorder

The police provided evidence of alcohol related crime in this area which relates primarily to domestic abuse and criminal damage, with this area identified as a hot spot in Medway for these types of alcohol related crime. The community safety unit has identified there is a problem with the availability of alcohol in this area and alcohol related crime.

Public Health continues to be concerned at the levels of domestic abuse in this area. Levels of domestic abuse has been consistent in this area since the implementation of the

cumulative impact policy. There is strong academic evidence that domestic abuse is linked to alcohol misuse.

The prevention of public nuisance

Luton is a hot spot for alcohol related nuisance consisting of anti-social behaviour, street drinking and alcohol related litter in the form of discarded bottles and cans. There is also evidence of public urination and defecation. Respondents to a questionnaire used as part of the evidence to support the CIP stated that alcohol bought from off licensed premises in this area contributes to the alcohol related problems, particularly nuisance.

A member of public health staff has attended Luton High St area on a number of occasions in preparation of these representations and there is ongoing evidence of alcohol related street drinking and associated litter throughout the area surrounding the High St, even with the recent lock down due to Covid 19. This litter consists of bottles and cans of beer and cider, both 'super strength' and regular strength and numerous empty bottles of vodka.

Of particular concern is the old graveyard at the bottom of Upper Luton Road, where my staff spoke to a resident. She did not want her name and address to be made public. She confirmed people were regularly gathering at this location to drink alcohol and she suspects drug use takes place. The resident described the behaviour as intimidating and unpleasant and had not decreased during the current situation. The resident's evidence was supported by the alcohol related litter found in the graveyard, along with broken glass from beer bottles and evidence of public defecation.

Staff also spoke to another resident, who was clearing up litter at the nearby church. He said he found discarded beer and cider cans and empty vodka bottles every week where people throw then over the wall to the church grounds.

Summary

Luton Road, Luton High Street and the surrounding area has unacceptable levels of alcohol related issues, including crime, domestic abuse and public nuisance associated with a high density of licensed premises, particularly off licences. With the recent lockdown due to Covid 19 there is even more concern due to the evidence suggesting people are consuming more alcohol at home. This location is also within walking distance of the Chatham High street CIP, with its problems of alcohol related harms.

Policies 10 and 17 from the Statement of Licensing Policy are the most relevant to this application. Policy 10 sets out the expectation of the Licensing Authority when determining applications for off licensed premises. This states that when an application is in a CIP area the Authority will refer to Policy 17, which outlines the expectations for applications made for off licensed premises in these areas.

Policy 17 states the Authority expects an application in a CIP area to contain a full explanation as to how the premises will not adversely affect the four licensing objectives. There is a rebuttable presumption of refusal by the Authority in all but exceptional circumstances. Offering conditions which merely show the premises as being well managed and run are not exceptional.

In this case the Director of Public Health believes there is nothing exceptional about this application as required by Policy 17. It is reasonable to believe the sale of alcohol from this premises will contribute towards the alcohol related crime, disorder, and public nuisance in this area, which are current and ongoing. The Licensing Committee is therefore asked to refuse the application.

- 2) The prevention of public nuisance

1) The prevention of crime and disorder

There is evidence in the Luton cumulative impact policy (CIP) of alcohol related crime and criminal damage in this area and this is exacerbated by a problem with the availability of alcohol in this area and alcohol related crime.

2) The prevention of public nuisance

It is my believe that there is a high risk of an increase in alcohol related nuisance - anti-social behaviour, street drinking, alcohol litter, public urination and potentially even defecation.

The area has high levels of alcohol related issues, including crime, domestic abuse and public nuisance associated with a high density of licensed premises, particularly off licences.

I am concerned about the applications to grant a sale of alcohol, as I live at No 1 Nelson Terrace my outlook is directly to the rear of the building and geo wise I am two doors away. We already have a public house (The Hen and Chickens) and an off licence plus two takeaways in very close proximity.

There is a long history of anti-social behaviour in this area which I have personally witnessed and is often caused by people drinking alcohol in public. I have seen groups gathering on the road and in the library car park drinking beer and cider and I believe drug use also takes place. These groups often walk down Nelson Terrace and stand in the small private car park at the end. There is shouting and swearing and fighting. I have seen people urinating up walls and defecating behind the walls of the library car park. Alcohol fuels a lot of this behaviour and it is easy to get hold of as I see people drinking all the time. The empty bottles broken glass and cans are dropped along the road ending up in people's gardens. Drunk people are intimidating, and they get louder and their language is unpleasant.

We wish to make you aware of several strong concerns that we have about the application for an off license for the sale of alcohol between 0900 and 2000 hours at MEDWAY FOOD CENTRE 43-45 LUTON HIGH STREET CHATHAM ME5 7LP, Off License application referenced above.

We are making these representations under the following licensing objectives;

- The prevention of crime and disorder;
- The prevention of public nuisance;
- The protection of children from harm.

Our Big Local area spans from The Brook and includes within its Luton Road and large part of Luton itself and we would consider it at that end to be a close neighbour to the site with many of our residents using the retail offering and post office located in it vicinity as part of their daily routine. Even more so recently since effects and the limitations imposed by lockdown due to Covid-19 pandemic.

Big Local it is a project where each area receives Lottery funding over the duration of the programs which is due to end in March 2026, which residents themselves will be in charge of spending on ways to improve their community from training and employment schemes to tackling anti-social behaviour, creating new community facilities or providing more activities for young people. Designed from the outset to be radically different from other funding programmes, at the heart of Big Local is a vision of empowered, resilient, dynamic, asset-rich communities making their own decisions on what is best for their area.

Big Local four over reaching programme outcomes;

- communities will be better able to identify local needs and take action in response to them;
- people will have increased skills and confidence, so that they continue to identify and respond to needs in the future;
- the community will make a difference to the needs it prioritises;
- people will feel that their area is an even better place to live.

Big Local was launched in three waves of 50 areas. Arches local was launched in the second wave which was announced in February 2012. Our partnership was formed in 2014 and our first-year plan was issued shortly after in March 2015.

The Big Local program is run by Local Trust, working with a £200m endowment from the Big Lottery Fund all funding has to be spent by Big Local areas by 2026 or it will be returned to the Big Lottery.

The Arches Big Local area in Medway has been classified as one of the most deprived areas in England. In the 2019 Index of Multiple Deprivation (IMD), the three areas of Medway 15E, Medway 20B and Medway 20D that have been used to define the area were ranked as the 144, 1279 and 1428 most deprived neighbourhoods out of 32,844 in England. The table below shows the overall movements since 2011;

Though there has been positive movement in the overall levels of deprivation from 2011. When we look at the marker Income Deprivation Affecting Children Index (IDACI) which measures the proportion of all children aged 0 to 15 living in income deprived families we see a worrying trend;

Medway 015E LSOA was ranked in IDACI 5,249 out of 32,844 in 2015 this was amongst the 20% most deprived neighbourhoods and has shifted dramatically in 2019 to being ranked 1,465 amongst the 5% most deprived neighbourhoods.

Medway 020D LSOA was ranked in IDACI 3,549 out of 32,844 in 2015 this was amongst the 20% most deprived neighbourhoods and worsening in 2019 to being ranked 2,293 amongst the 7% most deprived neighbourhoods.

Medway 020B LSOA was ranked in IDACI 1217 out of 32,844 in 2015 this was amongst the 5% most deprived neighbourhoods and improving in 2019 to being ranked 1485 but still within the 5% most deprived neighbourhoods.

As part of our journey since 2015 we have recorded the thoughts and comments from people living within and around our Big Local area. Here are some of the thoughts when asked what they did not like about the area around the negative effects of alcohol.

Unclean. Drunks; Hate the Drunks on the Streets; Drunks, Drugs, Litter; Poverty. Drug abuse. Alcoholics on street corners; Too much drug dealing and alcoholics;

The drugs addicts, The alcoholics, Nothing for the kids;

Drug and alcohol fuelled misbehaviour; Alcohol abuse.



The below comment encapsulates the general feeling and ours that there are already to many places in and around our area selling alcohol.

Not very clean, high crime, drugs, alcohol abuse, don't feel safe walking, unkempt, no local supermarkets except Sainsbury's, less brothels - they are a nuisance, too many fast food shops and shops selling alcohol.

We do believe that adding an additional place in or near our area that can sell alcohol will have a negative impact on the standard of living for all in and around that area. Our primary concerns around increasing the availability of alcohol beyond what already exists in and near our area is that it will undoubtedly increase alcohol related problems we are already experiencing around the following:

- Increase in street drinking;
- Related drug use;
- Anti-Social behaviour; drinking outside schools, fighting, swearing, urinating;
- Impact on children in poverty;
- Negative influence on children's behaviours and beliefs regarding alcohol due to it wide availability and cheap cost.



We are of the view that because of aforementioned points raised and that the establishment sits in a Cumulative Impact Policy area because of the negative effects of alcohol and that its recent renewal points to an ongoing problem that has not gone away. Therefore, we would request that Medway Council should refuse this application.

Finally, please note that our comments are in respect of the proposed off license application. While we have taken every effort to present accurate information for your consideration, as we are not a decision maker or statutory consultee, we cannot accept any responsibility for unintentional errors or omissions and you should satisfy yourselves on any facts before reaching your decision.
