Summary

This report advises Members of the current work programme for discussion in the light of latest priorities, issues and circumstances, giving Members the opportunity to shape and direct the Committee's activities.

- 1. Budget and policy framework
- 1.1. Under Chapter 4 Rules, Part 4 paragraph 21.1 (xv) General Terms of Reference, each overview and scrutiny committee has the responsibility for setting its own work programme.
- 2. Background
- 2.1. Appendix 1 to this report sets out the Committee's work programme.
- 3. Agenda planning meeting
- 3.1. Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. An agenda planning meeting was held on 23 September, attended by the Chairman, Vice-Chairman and the Opposition Spokesperson.
- 3.2. In view of the fact that the current requirement to hold meetings virtually tends to increase the length of meetings, Members considered that ideally there should be only four or five substantive reports on the agenda for this Committee meeting. Members therefore decided that the report on Adult Social Care Complaints and Compliments scheduled to come to this meeting should instead be circulated to the Committee as a briefing paper.
- 3.3. The agenda planning meeting also discussed which items should be considered at the special meeting of the Committee arranged for 12

November and have recommended that the following reports should come forward to that meeting:

- Community Mental Health Support (this was originally scheduled to come to this meeting but needed to be deferred)
- South East Coast Ambulance (SECAmb) Trust Update
- Domiciliary Care (listed on the work programme as Care in the Community)
- Dermatology Services (currently in the date to be determined section of the work programme)
- 3.4. The Committee is also recommended to add an item on the Parenting Support Strategy to the work programme for the March 2021 meeting.
- 3.5. Members asked for a briefing paper for the Committee on carers in light of the difficulties many may have faced during the pandemic, particularly for those who have been supporting shielding individuals or shielding themselves. The briefing will also look at engagement with the carers' network and how services have adapted during the Covid period.
- 3.6. As requested at the last meeting of the Committee, a briefing note prepared by the CCG was sent to Members on digital engagement and consultation. In the note there was a link to further reports on the results of recent engagement with people with Autism/ADHD that have been published on the CCG's website.

In response to this briefing note, there was a request that the issue of services to autistic adults should be added to the Committee's work programme given some concerns about what the engagement work showed in terms of services to autistic adults. This would allow the Committee to scrutinise the planned improvements.
