- 3. Agenda planning meeting

- 5. Performance Data Workshops
- 5.1. At the Committee's meeting on 5 March 2020, it agreed a number of measures to maximise its involvement and impact in relation to the scrutiny of children's social care.
- 5.2. Part of those measures included the provision of detailed performance data to all members of the Committee on a monthly basis and for performance data workshops to be provided, in between Committees on a 6-8 week cycle. The purpose of this is to strengthen the capacity for effective scrutiny of performance by providing an informal setting in which detailed analysis of the data can be undertaken. Members can then apply their increased knowledge and understanding to carry out an effective scrutinising role in main committee meetings and in task group activity.
- 5.3. The latest workshop was held virtually on 5 November 2020. This session was attended by the Head of Safeguarding and Quality Assurance and the Head of Service for Children's Social Work Teams, in addition to the Assistant Director, Children's Social Care, the Independent Chair of the Improvement Board and the Children's Services Commissioner, to allow Members to focus on the data relating to child protection. At the session, Members were able to interrogate the data and explore beneath the performance to understand the contributory factors and identify key areas for further focus.
- 5.4. Members raised questions on performance issues relating to topics such as caseloads, complexity of cases, staffing levels, use of the signs of safety

model, working with partner agencies, how the voice of the child is captured and listened to and the mechanisms for reviewing plans.

- 5.5. At the session, the Children's Commissioner also reported very positively about the how Members had been developing their role as an overview and scrutiny committee in relation to Medway's children's services improvement journey. This was echoed by the Independent Chair of the Improvement Board.
- 6. Headteacher position on the Committee
- 6.1 The Headteacher position on the Committee will become vacancy at the end of 2020, as Nicola Forrest comes to the end of her two year term of office.
- 6.2 Invitations for expressions of interest into the vacancy were emailed to all Medway Headteachers in October with a closing date of Friday 13 November 2020.
- 6.3 Nicola Forrest indicated she would be very happy to remain on the Committee for a further two years, stating that she "enjoys the discussions and seeing how everyone works together to achieve the best for Medway children".
- 6.4 An expression of interest was also received from Carl Guerin-Hassett, Principal at The Hundred of Hoo Academy. He has 15 years experience as a teacher, eight of those as a senior leader in London, Kent and now as Principal at the Hundred of Hoo Academy where he has been for 1 and a half years.
- 6.5 Given that Nicola Forrest has just completed her two year term it is recommended that, subject to consultation with the Chairman, Vice-Chairman and the Opposition-Spokesperson ahead of this Committee meeting, Carl Guerin-Hassett be appointed to the Committee and, given the valuable contribution Nicola has brought to the Committee's discussions, it is recommended that Nicola be appointed as Carl's substitute for a further two year term.
- 7. Implications for looked after children
- 7.1 Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent, Members should be a champion for looked after children and have the same high expectations of them as they would for their own child, grandchild or niece/ nephew.

- 8. Financial and legal implications
- 8.1 There are no financial or legal implications arising from this report.

#### 9. Recommendations

- 9.3 The Committee is asked to recommend the appointment of Carl Guerin-Hassett to the position of a non-voting Headteacher on this Committee to the Chief Executive, following consultation with the Group Whips, for a two year term, subject to the outcome of consultation with the Chairman, Vice-Chairman and Opposition Spokesperson.
- 9.4 The Committee is asked to recommend the appointment of Nicola Forrest as a substitute non-voting Headteacher on this Committee to the Chief Executive, following consultation with the Group Whips, for a two year term, subject to the outcome of consultation with the Chairman, Vice-Chairman and Opposition Spokesperson.
