Implementation of an online community lottery.

Anyone aged 16+ can take part in the lottery in line with gambling legislation.

Any good cause can apply to be a beneficiary of the lottery as long as they fulfil the following criteria:

- Provide services or activities that directly benefit people within Medway;
- Be independently established for charitable, benevolent or philanthropic purposes;
- Have a constitution or set of rules setting out its aims and objective;
- Operate a bank or building society account in its own name requiring at least two unrelated signatories;
- Place no undue restrictions on membership.

Proceeds from the lottery will be split as follows: 60% good cause, 20% prize fund, 20% costs.

## 2 Summary of evidence used to support this assessment

Local Community Lotteries have been running for several years as a sustainable means to raise funds by taking payments online, with no instant win option, the risk of the draw appealing to gamblers is reduced. The lottery is a giving scheme using a gambling infrastructure model.

## 4 Summary of the likely impacts

People with disabilities, or whose first language is not English, may be impacted due to the lottery being exclusively online.

Religious groups who may not agree with gambling as a method of raising income may not be able to benefit.

Young people under 16 will not be able to take part in the lottery. There are no restrictions on good causes working on behalf of young people under 16 being beneficiaries of the lottery.

We will speak to the External Lottery Management (ELM) company about what translation options might be available to make it easier for people who don't speak English to use the website. We can also work with the Communications team and VCS organisations to ensure marketing materials are available in alternative languages if requested.

Anybody struggling with access would receive the same type of support or assistance as they do for other online activities i.e. from friends, family, carers and supporting organisations.

There is free online access available throughout Medway via Libraries and other Community establishments.

We can consider promoting other options for donating to local good causes for those who cannot or will not engage with a local lottery.

No groups are disadvantaged in terms of applying for financial support.

The introduction of a local lottery can have a positive impact by enabling local voluntary and community sector groups, who often support people with protected characteristics, to access vital funds to sustain their operations.

The community lottery raises funds from the local community for the local community creating a direct link between the people playing and the good causes. Stories of winners and beneficiaries can help foster good relations between people from different groups and encourage more participation.
